The residential property at Aroona declared above is adjacent to Crown land that is designated as the Caboolture to Maroochydore Corridor Study (CAMCOS) now referred to as the Sunshine Coast Direct Line. I have received written advice from the Department of Transport and Main Roads on 9 August 2024 that the alignment has now changed, and that my property may be materially impacted. I have subsequently had a meeting with TMR representatives where I made a declaration at the start of the meeting pursuant to Standing Order 262. TMR advised that approximately 650m<sup>2</sup> of my land is materially impacted. This impact may lead to property acquisition. At all stages I have been receiving advice from the Integrity Commissioner and the Clerk of the Parliament.

Since becoming the Minister responsible for infrastructure, I have met with the Integrity Commissioner about the Sunshine Coast Direct Line. The Integrity Commissioner has provided updated advice and a Conflict Management Plan. I have executed the Conflict Management Plan on 27 November 2024.

The residential property at Aroona declared above is subject to the Sunshine Coast Planning Scheme Amendment which may impact on the zoning of the property.

As Minister responsible for planning, I sought the advice of the Integrity Commissioner. The Integrity Commissioner has provided advice and a Conflict Management Plan. I have executed the Conflict Management Plan on 25 November 2024.
