Minutes of the previous meeting:

The minutes of the meeting of 19 May 1992 having been circulated to members were taken as read and confirmed on the motion of Mr Sullivan and seconded by Mr Stephan.

Business arising:

31/92 Grammar Schools Act

The meeting endorsed the Committee's letter of 19 May 1992 and noted the Department's reply of 22 May 1992.

No further action is required.

Letter to the Government Printer

The meeting endorsed the letter to the Government Printer requesting copies of the Subordinate Legislation Series.

The meeting also discussed the availability of exempted instruments for the Committee's scrutiny.

It was resolved to write to the Premier seeking his assistance and advice regarding these instruments.

Business arising: (cont)

3/91 Traffic Act

The meeting discussed Counsel's annexure to report no 3/91 in which he advised that the amendment as recognised by the Minister has still not been gazetted.

The meeting resolved to again write to the Minister bringing this to his attention.

9/91 Mineral Resources Act

The meeting acknowledged the Minister's reply of 1 June 1992 and resolved to await the Minister's further advice from the Crown Solicitor.

13/91 Primary Producers' Organisation and Marketing Act

The meeting noted the Minister's reply of 3 June 1992 in which he advises that the Board has been requested to check future amendments with Departmental officers.

The meeting requested that Counsel provide further advice with regard to levies collected prior to the gazettal of the notice.

5/92 Forestry Act

The meeting noted the reply received from the Government Printer.

No further action is required.

27/92 Land Act - Regulation

The Minister's reply of 2 June 1992 was discussed.

The meeting resolved to await further advice from the Premier.

Business arising: (cont)

32/92 Sugar Industry Act - Guideline

The meeting noted that an amendment to the guideline has been gazetted.

It was resolved to write to the Minister noting the gazettal.

33/92 Architects Act

The meeting discussed the Minister's reply of 13 May 1992 and resolved to write to the Minister detailing the Committee's concern that whilst the schedule of fees are tabled there is no association to the particular Board in question.

34/92 Associations (Natural Disaster Relief) Act

The meeting noted the Minister's reply of 25 May 1992.

No further action is required.

35/92 Australian Financial Institutions Commission Act 1992

The Minister's reply of 28 May 1992 indicated that an amendment to the regulation was necessary.

The meeting resolved to await the gazettal of the amendment.

38/92 Credit Societies Act 1986

The meeting discussed the Minister's reply of 21 May 1992 and resolved that no further action is required.

Counsel's report:

40/92 Water Resources Act

Counsel reported that the error that occurred in the original order has since been amended.

No further action is required.

General business:

Annual Report

It was resolved by the meeting that the Secretary prepare the Annual Report of the Committee.

Legal advisor to the Committee
