- Confirmation of Minutes:** The minutes of the meeting of 28 May 1990 were confirmed moved Mr Dollin seconded Mr Fenlon.
- Staffing:** Agreed letter to the Minister for Transport to be prepared requesting secondment of a suitably qualified officer to assist in the Committee in its deliberations.
- Public Inquiry:** Resolved moved Mr Lester seconded Mr Fenlon that the Committee conduct a public inquiry into the following matters as detailed in item 4 of the Motion establishing the Committee:
- (a) the need for some form of compulsory periodic inspections of passenger vehicles as an effective means of reducing road crashes and the severity of associated injuries;
 - (b) the need to improve the standards of motor vehicle repairs as a means of improving vehicle and road safety.
- Submissions to be called commencing Saturday 16 June 1990.
- Future Inquiries:** Resolved moved Mr Dollin seconded Mr Fenlon to deal with the matter of current traffic law enforcement methods and penalties, and their effectiveness in conjunction with the question of driver education at a later date with public submissions to be called on or about 6 August with a closing date mid September 1990.
