**Consideration of Draft Report to Parliament:**

The following recommendations were reaffirmed. I, II, III, IV, V, VI, VII, XIII, XVI, XVII, XVIII, XIX.

Agreed that Recommendation VIII

'It is therefore recommended that the roadworthy certificate scheme be reviewed and that the Certificate of Roadworthiness be renamed Safety Certificate', be deleted.

Agreed that the following new Recommendations stand as part of the Report.

**Recommendation VIII**

It is therefore recommended that the roadworthy certificate scheme be reviewed.

**Recommendation IX**

It is therefore recommended that greater stringency be placed on the standards and number of new approved inspection stations to ensure that a high standard of inspection is achieved and maintained and that the roadworthy inspection scheme is viable.

**Recommendation X**

It is therefore recommended that dishonest and unscrupulous examiners and proprietors be removed from the system through a continual process of audit.

**Recommendation XI**

It is therefore recommended that used car yards be inspected at random to monitor the standard of certificates issued.

**Recommendation XII**

It is therefore recommended that the Certificate of Roadworthiness be renamed 'Safety Certificate'.

Agreed that the following recommendations be amended as follows

**Recommendation XV**

The word arbitrate substituted for the word arbitration.

**Recommendation XIV**

The word substantial be substituted for the word excessive.
