#### The Parliament of Queensland enacts—

#### Part 1 Preliminary

#### 1 Short title

This Act may be cited as the *Building and Other Legislation Amendment Act 2013*.

#### 2 Commencement

This Act commences on a day to be fixed by proclamation.
