#### The Parliament of Queensland enacts—

## Part 1 Preliminary

#### 1 Short title

This Act may be cited as the Appropriation Act (No. 2) 2015.

Note-

Under the *Financial Accountability Act 2009*, section 5, words used in this Act that are defined under the *Financial Accountability Act 2009* have the same meaning the words have in that Act, subject to a contrary intention in this Act.

#### 2 Commencement

Part 3 commences on a day to be fixed by proclamation.

# Part 2 Supplementary appropriation for 2014–15

#### 3 Supplementary appropriation for 2014–15 based on unforeseen expenditure included in the consolidated fund financial report

- (1) The Treasurer is authorised to pay \$9,110,000 from the consolidated fund for departments as stated in schedule 1 for the financial year starting 1 July 2014.
- (2) For each department, the total amount mentioned for the department in schedule 1 is appropriated for the financial year for the department for application to its departmental services, equity adjustment and administered items as stated in schedule 1.
