**An Act authorising the Treasurer to pay amounts from the consolidated fund for departments for the financial years starting 1 July 2017 and 1 July 2018**

## **The Parliament of Queensland enacts—**

### **1 Short title**

This Act may be cited as the *Appropriation Act 2017*.

*Note—*

Under the *Financial Accountability Act 2009*, section 5, words used in this Act that are defined under the *Financial Accountability Act 2009* have the same meaning the words have in that Act, subject to a contrary intention in this Act.

### **2 Appropriation for 2017–2018**

- (1) The Treasurer is authorised to pay \$50,851,083,000 from the consolidated fund for departments as itemised in schedule 1 for the financial year starting 1 July 2017.
- (2) For each department, the vote amount mentioned for the department in schedule 2 is appropriated for the financial year for the department for application to its departmental services, equity adjustment and administered items as stated in schedule 2.
- (3) The amount mentioned in subsection (1) includes the amount already authorised by the *Appropriation Act 2016*, section 3, to be paid for the financial year starting 1 July 2017.

### **3 Supply for 2018–2019**

The Treasurer is authorised to pay \$25,425,542,000 from the consolidated fund for departments for the financial year starting 1 July 2018.

### **4 Repeals**

The following Acts are repealed—

- Appropriation Act 2015, No. 11
- Appropriation Act (No. 2) 2015, No. 20.
