## The Parliament of Queensland enacts—

### 1 Short title

This Act may be cited as the *Appropriation (2020–2021) Act 2021*.

*Note—*

Under the *Financial Accountability Act 2009*, section 5, words used in this Act that are defined under the *Financial Accountability Act 2009* have the same meaning the words have in that Act, subject to a contrary intention in this Act.

### 2 Appropriation for 2020–2021

- (1) The Treasurer is authorised to pay \$60,857,652,000 from the consolidated fund for departments as itemised in schedule 1 for the financial year starting 1 July 2020.
- (2) For each department, the vote amount mentioned for the department in schedule 2 is appropriated for the financial year for the department for application to its departmental services, equity adjustment and administered items as stated in schedule 2.
- (3) The amount mentioned in subsection (1) includes the amounts already authorised to be paid for the financial year starting 1 July 2020 under each of the following provisions—
  - (a) the *Appropriation Act 2019*, section 3;
  - (b) the *Appropriation (COVID-19) Act 2020*, section 3(1);
  - (c) the *Appropriation Act 2020*, section 3(1).

### 3 Supply for 2021–2022

The Treasurer is authorised to pay \$30,428,826,000 from the consolidated fund for departments for the financial year starting 1 July 2021.

## **4 Repeals**

The following Acts are repealed—

- Appropriation Act (No. 2) 2018, No. 26.
