An Act authorising the Treasurer to pay amounts from the consolidated fund for departments for the financial years starting 1 July 2019 and 1 July 2020

The Parliament of Queensland enacts—

1 Short title

This Act may be cited as the *Appropriation Act 2020*.

Note—

Under the *Financial Accountability Act 2009*, section 5, words used in this Act that are defined under the *Financial Accountability Act 2009* have the same meaning the words have in that Act, subject to a contrary intention in this Act.

2 Supplementary appropriation for 2019–20 based on unforeseen expenditure included in the consolidated fund financial report

- (1) The Treasurer is authorised to pay \$1,114,025,000 from the consolidated fund for departments as stated in schedule 1 for the financial year starting 1 July 2019.
- (2) For each department, the total amount mentioned for the department in schedule 1 is appropriated for the financial year for the department for application to its departmental services, equity adjustment and administered items as stated in schedule 1.

3 Further supply for 2020–21

- (1) The Treasurer is authorised to pay \$28,635,094,000 from the consolidated fund for departments for the financial year starting 1 July 2020.
- (2) The amount mentioned in subsection (1) is in addition to—
 - (a) the amount already authorised by the *Appropriation Act 2019*, section 3, to be paid for the financial year starting 1 July 2020; and
 - (b) the amount already authorised by the *Appropriation (COVID-19) Act 2020*, section 3, to be paid for the financial year starting 1 July 2020.
