The Parliament of Queensland enacts—

Part 1 Preliminary

1 Short title

This Act may be cited as the *Emblems of Queensland and* Other Legislation Amendment Act 2023.

458 Validation of quorum and voting at particular meetings of parliamentary committee

- (1) Subsection (2) applies if, in a meeting of the parliamentary committee held during the validation period, the committee reached quorum only by counting 1 or more members of the committee who were not present in person.
- (2) The parliamentary committee is declared to be, and always to have been, as validly quorate as it would have been if the 1 or more members were present in person.
- (3) Subsection (4) applies if, in a meeting of the parliamentary committee held during the validation period, the committee decided a question by counting a vote of 1 or more members of the committee who were not present in person.
- (4) The question is declared to be, and always to have been, as validly decided as it would have been if the 1 or more members were present in person.
- (5) In this section—

parliamentary committee includes the Criminal Justice Committee of the Legislative Assembly established under the repealed *Criminal Justice Act 1989*, section 115.

validation period means the period—
