1 Short title

This Act may be cited as the *Appropriation (Supplementary 2023–2024)* Act 2025.

2 Supplementary appropriation for 2023–2024 based on unforeseen expenditure included in the consolidated fund financial report

- (1) The Treasurer is authorised to pay \$1,128,388,000 from the consolidated fund for departments as stated in schedule 1 for the financial year starting 1 July 2023.
- (2) For each department, the total amount mentioned for the department in schedule 1 is appropriated for the financial year for the department for application to its departmental services, equity adjustment and administered items as stated in schedule 1.
