## Re: Nature Conservation and other Legislation Amendment Bill 2015 Carnavon National Park Management Plan

Thank you for the opportunity to make a submission to the Committee regarding your deliberations on the Nature Conservation and other Legislation Amendment Bill 2015.

In the past years my family have leased approximately 60000 acres of the Carnavon National Park which is attached to my family property "Goathlands", which currently runs our organic beef operation. We wish to continue to use this land and believe our case to be unique from other entities. These special considerations include:

- There is **no public access** to this area of the National Park as the gazetted road ends at the boundary of Wealwandangie and Goathlands and to our knowledge such a road has never existed.
- This area of the National Park is **extremely rugged** and would not be suitable for public access. The only access at this time is through private property with no public access.
- During the time my family have used this land for cattle grazing we have never altered the natural terrain in any way, furthermore we **have not added any infrastructure** or water troughs on this land. We have endeavoured to maintain this land in its absolute natural state and believe we have been excellent custodians of the land. The only maintenance we have carried out on the land has

been fire protection and vermin control when required. These processes have been of benefit to the overall conservation of the Park and we would argue are superior to the Carnavon National Park Management Plan. Due to our **organic status** we are particularly careful to **maintain the Park under strict conditions** as required by the Australian Certified Organics, an organisation we are accountable to by audit procedures.

- Our **impact on the land is minimal**. We use this land approximately 3 to 4 months of the year when we run approximately 500 cows and calves during the winter. **This equates to one cow and calf to every 120 acres**. We would never leave the cattle on the Park land for longer than this period due to the poisonous component of the nuts from the Zamia Palms which drop in the spring/summer months and are particularly attractive to the cattle. If these nuts are consumed by the cattle it causes a bone disease called "rickets", making the cattle crippled and unsaleable. Therefore we can assure the Government that we would only use this land for 3 to 4 months of the year having absolute minimal impact on this land.
- The Nature Conservation and Other Legislation Amendment Bill 2015 concerns us greatly as it
  removes any discretion from the Department or the Minister to allow leases such as ours to
  continue, even though it can be proven that the lease has caused no harm to the conservation
  values of the Carnarvon National Park. If we lose access to the lease land, it affects the viability of
  our organic beef operation for no other benefit gained by Queensland. I urge you to consider
  incorporating some discretion into the Bill which recognises the sheer size of Queensland, the
  variability of different landscapes and ecosystems and the need to have different regimes in
  different localities. Ideally this would allow qualified Departmental officers to review all the
  information and undertake such inspections as necessary, so that they could approve the
  continuation of leases such as ours, which benefit the outcomes sought for the national park which
  adjoins us.

If an inspection was done on this land today the evidence would be clear. There is absolutely no environmental impact to the National Park as a result of our family using this land. The evidence in fact, would state clearly that we have been excellent custodians of the land and that our future practices would keep conserving this land better for generations to come.
