On this occasion the proposed introduction of the Racing Integrity bill will be the worst decision I have seen since I came into the Industry. I beg this government to come to your senses and not bring this in.

Ok, the Racing Industry was rocked with the Live Baiting Scandal and whilst I agree that drastic measure's had to be taken with that racing code, your dismantling of the Thoroughbred and Harness codes has been disastrous. Address the issues with in the Greyhouind code but the systematic dismantling of an entire industry has been unbelievable.
