SUBMISSION

I provide my submission in support of the continuation of the Current Vegetation Management Act 1999 and rejection of the changes proposed in the Vegetation Management (Reinstatement) and Other Legislation Amendment Bill 2016 ("the Bill").

I STRONGLY OBJECT TO THE INCLUSION OF THE REVERSE ONUS-OF-PROOF IN THE PROPOSED AMMENDMENTS TO THE VEGETATION MANAGEMENT ACT AS IT IS AGAINST THE RIGHTS OF ANY AUSTRALIAN TO BE PRESUMED GUILTY UNTIL THEY CAN PROVE THEIR INNOCENCE. FARMERS ARE DENIED THE RIGHT OF JUSTICE AND DESCRIMITATED AGAINST UNDER SECTION 24 OF THE CRIMINAL CODE: MISTAKE OF FACT.

I WOULD LIKE TO DRAW TO YOUR ATTENTION THE DANGERS OF REFUSING TO ALLOW FARMERS MANAGE REGROWTH. IN MANY INSTANCES THIS WILL DEGENERATE INTO AN IMPENITRABLE LANDSCAPE OF SUCKERS PROVIDING NO HABITAT FOR NATIVE WILDLIFE, WHILST THE ACTUAL GROUND COVER IS NONEXISTANT TO PROTECT THE SOILS FROM EROSION. THE GRASSES ARE ESSENTIAL FOR THE PRESERVATION OF THE SOIL PROFILES, PREVENTING DEGRADATION DUE TO EROSION.

I HAVE ATTACHED PHOTOS THAT CLEARLY DEMONSTRATE SERIOUS EROSION AND DEGRADATION IN THICK SUCKERED COUNTRY. IN CONTRAST, THE EROSION IS NON EXISTANT IN ADJACENT COUNTRY WITH GRASS GROUND COVER.
