21 August 2013	QYAC letter to Premier	Concerned that no one has briefed QYAC on tenure proposal, asked for briefing and for Government to communicate to Sibelco that ordinarily they would be required to negotiate an ILUA for a future act, raised concerns about no action on economic transition, and concerns about Minister Cripps misstatements to Parliament
26 August 2013	Deputy Director Skinner, various departmental officers	Discussions with Departmental officers on how to progress ILUA actions
8 October 2013	Letter from Premier to QYAC	No decision on amendments to Act or timeframe for way forward, Government has determined no breach of ILUA or impact upon Native Title Rights and interests
14 October 2013	Letter from QYAC to Premier	QYAC requests opportunity to brief the state on what interests are affected, and what the breach of ILUA will be
17 October 2013	Minister Cripps phone message on QYAC CEO phone	Courtesy call to let QYAC know that a Bill was being introduced that day to amend the NSI Act.
17 October 2013	Minister Cripps reads Bill	Hansard. Press release asserting no impact on Native Title Rights or breach of ILUA, no impact upon environmentally sensitive areas.
