The Queensland Teachers' Union (QTU) welcomes the opportunity to make a submission in relation to the inquiry into the Queensland Parliamentary Committee system.

Established in 1889, the QTU is the voice of more than 43,000 teachers in the Queensland Government's primary schools, secondary schools, special schools, senior colleges, TAFE colleges and other educational facilities.

History of the Parliamentary Committees

Parliamentary Committees originally evolved from those in the British Parliament starting in the 16th century. They were established to perform functions or investigate matters which were either too complex or too technical for the normal routine of parliamentary business.

May 1860 - May 1863: Queensland parliament established 23 committees in order to establish a stable, functioning colony and assist the fledgling parliament.

July 1902 – committees focussed on the internal workings of the Parliament. Parliament established only seven committees.

1988 and 1989 - Establishment of the Public Accounts Committee and Public Works Committee. - Scrutiny of the executive began.

1990 –Inclusion of several new committees that had oversight of the government departments and associated public bodies reinvigorated the committee system, some as a direct result of the Fitzgerald Inquiry $^{\rm 1}$

1992 – Upon Parliamentary Committee for Electoral and Administrative Review (PCEAR) recommendations, Parliament established eight scrutiny and oversight committees.

Since 2011, the Parliament has adopted a system of portfolio committees. In Queensland, most parliamentary committees are established permanently by legislation, usually the Parliament of Queensland Act 2001.

Purpose of the Bill

The objectives of the Bill are to:

- statutorily recognise the 'core matters' of the parliamentary committee system in the Constitution of Queensland 2001 (the Constitution); and
- provide that the Parliament's portfolio committees are able to initiate inquiries within their area of responsibility on their own motion.

The recommendations that arose from the Committee of the Legislative Assembly (Report No. 17 *Review of the Parliamentary Committee System*, 25 February 2016) have been implemented in this Bill.

Why does the QTU support the Bill?

The QTU believes that the Parliamentary Committee process is a very important one. Testament to this belief is the extensive list of Submissions lodged by the QTU to the relevant committees on various issues that are of importance to its members and Queensland people in general².

The QTU believes that the accountability provided by the Parliamentary Committee system is important to the Queensland public and unions. Because Queensland has a unicameral parliament, the absence of an Upper House increases the importance of committees in assisting the Parliament to effectively hold the Government to account on behalf of the Queensland people.

By providing a forum for discussion and investigation into issues of public importance, committees gives members of the voting public an opportunity to enhance their knowledge of such matters and have input. Policy and administration functions of Government are made more open and accountable by the existence of Committees.

In summary the QTU believes that the intentions of the Constitution of Queensland and other legislation Amendment Bill should be realised. The QTU would like the 'core matters' of the parliamentary committee system in the Constitution to be statutorily recognised, and Parliament's portfolio committees to be able to initiate inquiries within their area of responsibility, on their own motion.

As indicated in the *Review of the Parliamentary Committee System*, the QTU agrees that the passing of the Bill will not only emphasise the importance of the committee system but "place a psychological political impediment on altering them without just cause".
