**Subject:** REJECT The Queensland Community Safety Bill 2024

To all concerned:

This bill MUST be stopped and shredded.

A quick read has found:

1. It gives power to strip firearm licences from people because of things their family members do. This is outrageous.
2. Forcing people to take down social media posts the authorities don't like removes our birthright to free speech.
3. It expands situations where police can search people without a warrant. This is disgraceful and disregards our birthright, human right, and right to privacy and freedoms and justifiable reasoning with a warrant.
4. 13 years imprisonment for "weapon offences" is disgusting. Murderer convictions attract only 1-4 years or much less generally or suspended sentences and plea deals, and sex offenders are generally not jailed at all. This is nothing but an attempt to remove guns and firearm licences from law abiding citizens in Queensland. This disrespects our rights to freedom and liberty. "Community safety" is not an excuse to trample the rights of individuals. We are not a herd of cattle or flock of sheep. This is treason and must be stopped.
5. Victims still remain voiceless while convicted felons and alleged offenders have all the rights while victims and the community have none. This is not justice.

You are instructed to:

1. Remove all legislation that allows any search of people, property, belongings without a warrant. Warrants must be obtained for all occasions regardless of time sensitivity. It is better to preserve rights.
2. Immediately legislate that citizens can sue police officers corporately and individually for wrongful arrests, wrongful imprisonments, and victims are to receive substantial compensation.
3. Immediately legislate that perpetrators, alleged offenders and convicted felons lose all rights in line with community standards and expectations. Victims and the community are to retain all rights thereof.

7. The Firearms Prohibition Order is to be abolished. I do not accept that:

a. Organised crime groups, "outlaw" motorcycle gangs are trafficking in illegal weapons. That's a dangerous fabrication and propaganda that does not keep a community safe. Note: Definition of propaganda is war against the people!

b. Law abiding citizens should not be punished for the crimes of one individual.

c. QPS must be disarmed to prevent loss of life within the community. [REDACTED] Their immunity and impunity must be removed. If we the communities must be defenceless (for their ease of control over us), then so must the police - no guns, no tasers, no batons, no pepper spray, no knives, no screwdrivers, no sharp pencils.

8. To keep the community safe we must legislate that citizens are permitted to use deadly force against all intruders in our home, our property and when we are travelling and when we witness a crime taking place.

9. The alleged "theft" or "misappropriation" of firearms is rubbish. Another lie. There is an increase in firearms because the community does not feel safe and citizens can see the writing on the wall of threatened actions towards them and others by especially the police. This is demonstrated by the murders of many citizens. This does not keep our community safe.

10. It is our birthright to be able to defend ourselves, our families, our property even against the police [REDACTED]

11. The Community Safety Act lists excuses that weapons will fall into the hands of "high risk individuals." More fabrication. The community should not be hog tied for the rogue actions of an individual or government or police "false flags" in order to restrict the freedoms and rights of law abiding citizens.

12. There is no evidence that huge numbers of firearms are being stolen which causes police to be afraid. Sounds like a conspiracy.

13. Reviewing the Weapons Act to identify further removals of freedoms and rights and civil liberties for gun owners and calling it "community safety" is outrageous. You are to cease and desist from eroding all manner of our human rights and freedoms including having a firearms licence and maintaining guns and rifles.

15. Operational changes to digital paperwork is not to occur. It is evident that digital is unreliable, easy for AI to manipulate and change to commit injustice and fraud, easy to "share" with anyone who wants it, denies inalienable rights to privacy, and freedoms of choice and informed consent to individuals which must be preserved at all costs. Email is not acceptable to receive "infringement notices, summons, service of documents." And if the individual does not receive these notices or court dates, warrants are issued for their arrest. This is unacceptable. This is tyranny. The government and police are to cease and desist from their tyrannical behaviour towards law abiding citizens. This is not community safety.

16. Amending the Weapons Act to reject firearm licences for people with criminal records beyond the 5 year exclusionary period is reprehensible and must not be legislated. This is nothing more than reducing the number of licence holders in Queensland which is the right of individuals within the community. Firearm licences are critical for community safety.

17. The alleged public safety agenda denies individual rights, their birthrights, and is a proxy to denying all human rights and freedoms for every choice leaving total control and enslavement of the community. This is not community safety.

18. Removing anyone's ability to have a firearms licence denies their freedoms, civil liberties, human rights and birthrights which must not be allowed to happen.

19. Regarding the knife related paragraphs - all individuals must be allowed to carry on their person and in their possession at least a fold up knife or pocket knife or blade knife and not be arrested for an offence which the police and government want that individual to spend 13 years imprisonment. This erodes public confidence and community safety.

20. All of these amendments are over reach, remove human rights from everyone, increase tyrannical power of the government and police. We have seen the brutality of the police against law abiding citizens demonstrating for their human rights and unlawful actions of police and the government during the "covid" scandal. That was not for "community safety" but an elaborate agenda sorry, conspiracy against the people. Removing our rights and freedoms does not make a community safety. It only generates fear and dread because the police no longer serve and protect the community. Rather, they serve and protect criminals, and themselves.

21. Removing online content because the "authorities" don't like it or it is contrary to the government and police misinformation and disinformation narrative is unAustralian and unacceptable. It denies our basic human rights to free speech. The Voice referendum is a clear example of misinformation and disinformation by the Labor government to deny the community's right to truthful information in order to make informed choices. The "covid" experimental medical procedure is another clear example of the over reach and conspiracy from government especially and police were willing violent enforcers. This was in the interest of "public safety" but no community was safe.

22. By far, it is not human activity that is a problem, but AI. Therefore, AI must be criminalised to safeguard human intelligence, human intellectual property and human rights and freedoms of speech, creativity and privacy.

23. Instead of punishing the community for offenders publishing their offences online, police and "law courts", judges, Premier are not interested in actually charging and jailing these offenders, so why legislate against social media companies or alleged offenders and the community as a whole? No violent movie or game or war is censored or content removed. Daily we see ad after ad for alcohol and gambling and abortion (killing a human). You all do nothing. ██████████

24. Refusing to allow people to watch the knife attack of the "priest" in Sydney denies people's rights to determine for themselves what happened, instead of the police and government telling us what happened which was abundant past experience, is generally not the truth but only propaganda to fit in with their agenda of controlling the narrative and thereby the people. This is not community safety. This is communist control of the people. (Note: I chose not to watch that video as is my right!)

25. Our perceptions or feelings on un-safety is due to a lack of QPS charging offenders, judges giving injustice, no punishment (yet you want weapon offenders to go to jail for 13 years!!!) and criminals to have ALL the rights. There is no restitution to victims. It is illegal for victims of rape or murder to name their attacker in public even if he was convicted of the crime. That's discrimination and sexist.

26. The government insists detainees and immigrants cannot be detained or imprisoned for crimes or deported because it could affect their mental health yet you want the Weapons Act amended so alleged offenders are given 13 years jail!!! That's hypocritical!!! How about protecting Australians from these dangerous immigrants and deport

them

27. Cracking down on serious vehicle offending:

a. That is laughable and evil.

b. A husband has a DVO against him, deliberately runs over his wife a couple of times to make sure she is dead, murder charges are dropped and he accepts a plea deal for something like occasioning death with a motor vehicle. Where is the justice in that? He gets something like 4 years suspended sentence (yet you want to amend the Weapons Act to punish anyone carrying a knife or a screwdriver or... with 13 years jail. This is not a maximum but a mandatory sentence. This is a disgrace!)

c.

d. Stop punishing the community saying it is for our safety when it is not. It never is. We are not animals. We are created individuals with individual thinking, behaviour, choices, souls, rights to live as we see fit. We do not need or want to be controlled by government or police enforcers. Restore our birthright to justice, meet community expectations for crimes committed, restore community and law abiding citizens and victim's rights in all regards and remove rights from perpetrators, criminals and convicted frlons.

e. Our soldiers lose all civil rights on enlistment, so how much more should perpetrators and offenders lose theirs?

28. Yes, police should investigate ALL crimes, not pick and choose and ignore most. Paperwork has always been part of the process. Stop whinging and just do it.

29. It is not because of mistakes in paperwork that allow alleged offenders to have charges withdrawn. No, it's not. I know this because I have witnessed it. Instead of acquitting the person police would rip up the paperwork and redo it. It is known that if the plaintiff does not appear in court on the date prescribed, the respondent or defendant is released. Not when the police are involved. If the officer does not turn up at court the case proceeds and the judge takes action against the defendant. As a judge said, court is not about truth or justice. Well... we had better restore that!

30. Of course, there is one law for the police and one for the community. If you are not in the boys club you'll be imprisoned for 13 years if you were carrying a butter knife or screwdriver or spade or sharp pencil or pen.

31. Police are handsomely paid. So, do all aspects of the job!

32. There is not enough time to go through all 100 pages of these amendments. The day or two we have had is insufficient to submit a fully detailed coherent submission. This shows me again, the lack of consideration for individuals and the community, their thought, their reasoned contributions does not bear any interest with this government. That is not in the interests of community safety.

33. Having a mere day or 2 to respond to these amendments is outrageous and testifies to the government, QPS, and stakeholders in removing the last bastion of our rights and privacy as fast as they can, for surveillance, control and digital or analogue prison, all in the name of "community safety" is shameful. It has NOTHING to do with community or safety.

34. You owe our residents an apology for trying to pull the wool over our eyes securing our death warrant, which might be the real reason for these terrible enslaving rushed amendments that cause immeasurable harm to our community members.

35. We do not want tyranny. We want justice and truth:

a. We do not want to give up the last vestiges of our rights.

b. We surrender nothing.

c. Our human rights, free speech, privacy belong to us as individuals.

d. We reject more dictatorial, authoritarian control, surveillance, warrantless searches, punishing firearm licence holders with catch phrases in the name of "community safety" or "consent to this or you go to jail for 13 years."

e. NO!!!

f. Remove ALL warrantless searches including the ones currently legislated.

g. Stop giving all rights to perpetrators and offenders and zero to victims and the community.

h. Show compassion often. Give cautions to law abiding citizens regardless whether they have a firearm licence or not.

i. Charge offenders for home invasions and trespassing instead of home owners and property owners being charged with assault or grievous harm if they manage to defend themselves and injure the perpetrator.

j. Return to morality!

k. Go back to protecting and serving the community - not bashing them, lie and give them some sort of infringement notice or charge or take their guns off them.

l. You are instructed not to push these amendments to various legislations through parliament, but are to cease and desist from doing so.

m. I am your employer and you are to refrain from progressing this Community Safety Bill 2024. It is dreadful and has nothing to do with Community Safety.

In closing, take note that 2 weeks (only a day or two in reality. This was done in secret or certainly haste, and the timeframe is extremely deficient for "community" consultation. Remember, you insisted this was for "community safety" so why did you not allow the "community" to digest this Bill and respond with a comprehensive submission?
