Dear Committee Secretary

Thank you for the opportunity to review the *Inquiry into the Victims' Commissioner and Sexual Violence Review Board Bill 2024*, and to provide feedback on behalf of the Queensland Family and Child Commission (QFCC). The QFCC has previously provided submissions to the *Women's Safety and Justice Taskforce*, as well as separate policy submissions regarding domestic and family violence, and support provided to victims of crime. I have provided references to our previous policy submissions within this response.

The QFCC supports the appointment of the Victim's Commissioner, and the remit of the Commissioner including to identify and develop additional accessible resources to provide greater access to victim-survivors to understand their rights and navigate the criminal justice system and victim support system and raise awareness of the rights of victim-survivors and the services available to support individuals and families. We appreciate the impact on victim-survivors to engage with a system whilst managing the personal effects of trauma and recognise the intentions of the office of the Victims' Commissioner to identify improvements in how government agencies interact with and respond to the needs of victim-survivors in a sensitive and trauma-informed approach. To date, the QFCC has nominated a representative to participate in the *Interim Victims' Commissioner Stakeholder Reference Group* and will continue to provide our expert advice and assistance to the group.

I have considered the proposed Bill and provide my support. I note the importance of the *Charter* of victims' rights providing definitions for family members impacted by a crime against an individual, understanding that the effects of violence and harm are not discrete, and can have long term impacts on a wider network of affected persons. I also note the intention to provide a channel for raising complaints of contraventions of the *Victims' charter* to the office of the Victims' Commissioner, and for the Commissioner to make enquiries to understand the complaint and provide advice to support the victim-survivor or affected person/s. Such complaints raised to the Commissioner can assist to identify systemic issues which may support the office of the Victims' Commissioner to services.

In our April 2022 submission to the *Women's Safety and Justice Taskforce*, we highlighted the barriers to reporting as experienced by Queenslanders, including: concerns of the impact of their reporting on their family and friends, other persons finding out about the reported violence and, concerns around the likelihood that a court process would not be successful in holding the perpetrator to account, given the low conviction rate for sexually violent offences. I support the establishment of a review board which will conduct targeted reviews into systemic issues such as those detailed in the QFCC submission, to better support individuals and families impacted by sexual violence, reduce systemic distress upon victim-survivors, and provide meaningful recommendations to improve processes.

I welcome the proposed establishment of the Victims' Commissioner and Sexual Violence Review Board and acknowledge the action taken to implement the recommendations from the reports of the Women's Safety and Justice Taskforce, the Commission of Inquiry into Queensland Police Service responses to domestic and family violence, and the Inquiry into Support provided to Victims of Crime.
