## Public hearing on the Parliamentary committee system

A parliamentary committee will hold a public hearing as part of an inquiry into how the parliamentary committees system can be improved.

The hearing will be held in the Parliamentary Annexe, Alice Street, Brisbane on Friday 20 August 2010 from 8.30am.

Witnesses include the Parliament's Speaker, Hon John Mickel MP, and the Clerk of the Parliament, Mr Neil Laurie. (A copy of the public hearing program is attached.)

Members of the public are welcome to attend.

The Committee System Review Committee is conducting an inquiry into how Parliamentary oversight of legislation could be enhanced and how the committee system could be strengthened to enhance accountability.

The committee is considering the effectiveness of various changes introduced in early 2009, which include the establishment of a number of portfolio-based committees with an increased policy role.

The Committee is to report to the Parliament by **31 December 2010**.

## TERMS OF REFERENCE

The Committee was established by the Queensland Parliament on 25 February 2010. It is conducting an inquiry and will report on how the Parliamentary oversight of legislation could be enhanced and how the existing Parliamentary Committee system could be strengthened to enhance accountability. The resolution establishing the Committee goes on to provide that:

In undertaking this inquiry, the Committee should consider -

- the role of Parliamentary committees in both Australian and international jurisdictions in examining legislative proposals, particularly those with unicameral parliaments;
- timely and cost effective ways by which Queensland Parliamentary Committees can more effectively evaluate and examine legislative proposals; and
- the effectiveness of the operation of the committee structure of the 53rd Parliament following the restructure of the committee system on 23 April 2009.

The committee should include in its report options on models for structuring the Queensland Parliamentary Committee system.
