To whom it may concern

Stop the extension of the Emergency Bill till 31st of October.

This is leaving me and so many other people feeling distraught and powerless. I am going to lose my job because of these mandates and with an extension till end the of October I fear not only my mental health but my financial situation will be greatly affected . I have not been allowed into a restaurant or anywhere that is mandated because of this choice. These mandates are causing segregation and discrimination amongst our communities. When will this madness end, when will enough be enough. When do we go back to “living with the virus”. People need to be able to choose for themselves what goes into their bodies without repercussions.

These mandates are destroying people’s lives and ripping families apart . My teenage son has also lost his job due to mandates thus losing his independence. This has affected his self esteem greatly . We want to teach and encourage our young people to become valued members of the community. But these mandates have taken that ability away .

All this for Virus that if unvaccinated has a 99.7% survival rate . Especially now since the CHO stated on the 11th January that COVID is “just another virus “ . If it is just another virus why aren’t people being allowed to make a personal choice. Why do they need to extend these powers if it’s just another virus ?

The Prime Minister Scott Morrison stated that the vaccines don’t work against Omicron. The Pfizer executive also stated the two doses provides “limited protection if any against Omicron”. Data from Denmark and The Canadian province of Ontario indicates that vaccinated people have a higher rate of Omicron infection then the unvaccinated . So it seems vaccinated and unvaccinated perhaps have an equal chance of catching or spreading Covid. So again what reason do they have for extending these powers ?

It’s even been revealed by Ben Fordham on 2GB Sydney that 92% of Australians that supposedly died of COVID had underlying health issues. So I ask again why do the emergency powers need extending when it seems there clearly isn’t a pandemic. Why aren’t the government instead educating and encouraging people to get healthy.

There has also been well documented data and information released that discusses the importance of preventative and early treatment protocols for Covid 19 . Dr Peter McCullough stresses the importance of an early treatment regimen starting with a Nutraceutical bundle including things such as zinc, Vitamin D and C.
