# SUBMISSION : PUBLIC HEALTH AND OTHER LEGISLATION (EXTENSION OF EXPIRING PROVISIONS) AMENDMENT BILL 2022

The following submission addresses major issues associated with the proposed extension of the operation of essential public health measures, implemented to facilitate Queensland's response to the COVID 19 pandemic.

In the Hon. Ms D'Ath's presentation of this Bill, a number of statements were made that are false or outdated. I have written to Ms D'Ath several times seeking clarification on such comments, but to date have not received a response to my enquiries. As this evidence would have to be readily available to make such statements, it can only be assumed the evidence does not exist.

The state of emergency directives delivered by Queensland Health to date have been destructive to businesses, tourism, community cohesion, mental health and public healthcare. There has been no consideration given toward the now broad levels of natural immunity in the community; the reduced severity of the omicron variant; studies proving that pandemic measures such as lockdowns and masks are ineffective and in fact harmful; as well as the now strong evidence that vaccines are unsafe for some individuals and broadly ineffective at stopping transmission, disease or even death in others.

This is of great concern, as it demonstrates either a lack of transparency, or understanding by Ms D'Ath and the Queensland government. Either proposes potentially devastating consequences for the people of Queensland.

Worldwide data and peer reviewed science is proving to be increasingly contrary to Ms D'Ath's claims. So prior to this Bill being considered, it would be prudent to first seek from the Queensland government, irrefutable evidence to the following:

- 1. The existence of a pandemic
- 2. The success of preventative measures implemented to date
- 3. Proven safety and efficacy of Covid-19 vaccines
- 4. Explain why natural immunity continues to be ignored
- 5. Explain why proven early treatment protocols have been blocked

Their evidence should be at hand as it would be necessary in determination of this Bill.

Following are key comments with supporting evidence to counter the above points and demonstrate that an extension of the current state of emergency is not only unjustified, but would at this stage be potentially criminal.

# 1. The existence of a pandemic

Worldwide, countries are increasingly removing covid restrictions and returning to a pre pandemic life. The Australian Bureau of Statistics has confirmed by the latest death statistics that we may never have experienced a pandemic in the first place. Data to 31 Jan 2022 states:

2,556 deaths directly linked to Covid 19

83.7 is the median age of deaths (average life expectancy is 83.94) 220 had only Covid 19 referenced on their death certificate (all others had other comorbidities)
