Submission against Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022

I do not want the State of Emergency extended because it is a drastic overreach for a virus that has not killed as many people in Queensland as the seasonal flu and there are more people who have died or are seriously maimed from side effects of the mandated vaccines than have died from and not with Covid. Masks weaken the immune system and are child abuse. You cannot sue big pharma for the side effects of their dangerous vaccine products. No government should be denying their citizens access to any public location based on their vaccination or mask status. Queensland only had 6 deaths in nearly two years when very few people were vaccinated but now that you have over 90% double vaccinated we have more cases and deaths than ever before. These inoculations clearly do not stop you from getting Covid, stop you spreading it or stop deaths from Covid. All countries in the world with high vaccination rates and banning of antiviral treatments like Ivermectin are proving this to be the case. It is the vaccine that is killing people, not the Corona virus, and those that die with the virus likely had a weaker immune system from the side effects of the vaccine and wearing masks. There are too many suicides, ill health and economic ruin caused by lockdowns, vaccine mandates and masks that all politicians should be personally held accountable for all their callous disregard of human life and civil rights.

My son was severely brain damaged by the MMR vaccine at 17 months of age. He is 30 years old now but functions as a two year old requiring 24/7 care. He cannot have another vaccine due to so many health issues, and cannot get an exemption by doctors because they are more afraid of losing their medical license than protecting their patients. He is denied access to many places we and his support worker want to take him due to his Covid unvaccinated status. By denying him access to many places in Queensland and asking him to share his vaccine status to strangers Queensland politicians are violating :

- 1) Australian Human Rights Commission Act of 1986
- 2) Biosecurity Act of 2015
- 3) The disability Discrimination Act of 1962
- 4) Privacy Act of 1988
- 5) Section 51 (xxiiA) & 109 of the Australian Constitution

The removal of our civil rights should never be considered again by any politician in Australia.

Thank you for your consideration of this submission and I hope politicians will see reason and vote against the extension of such an unjust and dangerous Act which should never see the light of day again.
