#### SUBMISSION TO THE QUEENSLAND PARLIAMENTARY COMMITTEE INQUIRY INTO

#### EXTENDING QUEENSLAND'S 'STATE OF EMERGENCY':

Under the Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022, Queensland's 'state of emergency' laws will be extended from 30 April 2022 to 31 October 2022.

I am AGAINST the extension of the 'State of Emergency' in Queensland.

# REASONS FOR MY POSITION ON THE MATTER:

## 1. COVID-19 IS NOW A MILD ILLNESS:

- My husband aged 52, son aged 26, daughters aged 24 and 22 have all had COVID-19 they
  had symptoms for 2 4 days plus tiredness for about 3 more days. Symptoms were a
  headache fever for 1<sup>st</sup> day then some aches, pains and fatigue for the remainder. RAT and
  PCR confirmed.
- They now have natural immunity. Natural immunity has been found to be far superior to any
  medical intervention e.g. vaccinations (which have been found to not confer any sterilising
  immunity, and the supposed claim of reducing hospitalisation and death is not proven or
  backed up by the data from UK and Israel).

#### 2. THIS STATE OF EMERGENCY IMPACTS ABILITY TO WORK:

- I am a school administration officer and I need to get back to work. I am currently on leave, seeking a reprieve with the 'critical return to work directive, or thereafter, I will be suspended and not allowed on site due to my choice not to take a medical intervention that does not stop me from catching Covid.
- We are suspended and not allowed on site, because we have not taken a medical procedure
  that has been proven is not doing what it was supposed to do! The vaccine and the
  mandates have failed in their promised effectiveness. There are thousands of people
  without work, because of this!

- Mandates on doctors, nurses, paramedics, police officers, supermarket workers, etc must be lifted as these people need to return to work. Threatening people with their livelihood does not serve the community health, it creates division, takes away our human rights, promotes Discrimination, is unfair, unjust, is not about health, is coercive.
- It is coercive to DEMAND that I am vaccinated to do my job. Vaccination guidelines say that it is illegal to force anyone to take a vaccination. There must be full valid and informed consent. I cannot consent while I am threatened with my job.

# 3. HOW THE EMERGENCY LEADS TO RUSHING A VACCINATION PROGRAM AND THE DANGERS OF RUSHING SOMETHING LIFE-CHANGING.

Vaccinations must be voluntary and people must provide valid and informed consent.

Valid consent is the voluntary agreement by an individual to a proposed procedure, which is given after sufficient, appropriate and reliable information about the procedure, including the potential risks and benefits, has been conveyed to that individual.<sup>8-12</sup>

As part of the consent procedure, people receiving vaccines and/or their parents or carers should be given sufficient information (preferably written) about the risks and benefits of each vaccine. This includes:<sup>13</sup>

- what adverse events are possible
- how common they are
- what they should do about them

<u>Table. Side effects following immunisation for vaccines used in the National Immunisation Program schedule</u> can be used to inform valid consent.

Criteria for valid consent

For consent to be legally valid, the following elements must be present: 12,14

- 1. It must be given by a person with legal capacity, and of sufficient intellectual capacity to understand the implications of receiving a vaccine.
- 2. It must be given voluntarily in the absence of undue pressure, coercion or manipulation.
- 3. It must cover the specific procedure that is to be performed.
- 4. It can only be given after the potential risks and benefits of the relevant vaccine, the risks of not having it, and any alternative options have been explained to the person.

The person must have the opportunity to seek more details or explanations about the vaccine or its administration.

The information must be provided in a language or by other means that the person can understand. Where appropriate, involve an interpreter or cultural support person.

Obtain consent before each vaccination, after establishing that there are no medical condition(s) that contraindicate vaccination. Consent can be verbal or written. end quote.

- 1. I have tried to get a list of ingredients in the (Emergency Use) "approved" Covid vaccines from the National Centre for Immunisation Research and Surveillance (https://www.ncirs.org.au/health-professionals/covid-19-vaccines) and the only ingredients that I could find had the word exipients and the list of exipients. I looked up the meaning of exipients (which the average person like myself would think meant ingredients as it is under the word ingredients and it means: an inactive substance that serves as the vehicle or medium for a drug or other active substance. "excipients are things like colouring agents, preservatives, and fillers"
  - I looked for a list of ingredients but could not find the list. For vaccines under the National Immunisation Program there is a Table showing side effects from the vaccines used in the program (see above), but for these Covid vaccines, there is no table warning of the side effects. If it does exist, it is not easy to find and I think that the thorough pre-screening of vaccination recipients as required by the Australian Immunisation Handbook is very possibly not taking place as a consistent practice (in my reasonable opinion) due to the emergency creating a sense of urgency and not factoring in that many people are not suited to these vaccines (one size does not fit all).

## 4. NO COVID-19 EMERGENCY:

- There is no emergency. The recent weather event which has caused flooding in the South East Region has shown that the fear of Covid is over.
- There have been no excess deaths compared to the yearly seasonal flu. In fact, the
   Australian deaths from Covid (not with Covid) are under 100 (according to government's
   revised figures).
- The reported large Case numbers since the Covid-19 outbreak in Australia that are promoted are not evidence of illness. A case is a positive test result. It does not state that someone is ill. A lot of cases are doubled due to repeat tests. I myself reported my case twice, as per what was required at the time i.e. to report my positive Rapid Antigen Test, then I had a positive PCR test, which would have shown up as 2 cases reported. Also, positive test results were sometimes false positives (as PCR tests have been found by overseas countries like Portugal, UK, USA, etc to be unreliable in their ability to distinguish between the flu and Covid-19).
- There is no Covid-19 emergency. We have seen the effect of countries like Sweden having no lockdowns, no mandatory vaccinations, no mandatory mask wearing still have a reasonably high vaccination rate and far less cases of Covid-19 than countries like Australia that instituted lockdowns, and mandatory measures.
- The UK and other countries have stopped all mandates and states of emergency, so why is Queensland still considering this extension?
- We the public have heard announcements from government ministers saying that we have to live with Covid. It cannot be totally eradicated. There have been far more deaths from the flu than Covid and we have not declared a State of Emergency for the flu or many other

- death causing conditions. Extending this State of Emergency is just unnecessary and causes untold hardship to businesses, families, and the community in general.
- We must stop using extreme measures such as mandates and lockdowns (and mask wearing just is such a bad health option and does not stop any virus but weakens the immune system - WHO and medical experts have studies on these facts).

## 5. IS THE EMERGENCY REQUIRED SOLELY FOR THE PURPOSE OF VACCINATION?

- When there was an emergency (which we have now found is questionable due to no excess deaths worldwide), vaccinations were proposed as the answer. Now that the emergency is over, it seems that the emergency needs to be prolonged in order to serve the ability to use the current vaccines as they are only Provisionally Authorised (during Emergency Use Authorisation only). The vaccines have failed to give the protection that was promised!
- Australia used to have reasonable strategies for epidemics and they worked. There was no need to require a State of Emergency or Emergency Powers (except to allow untested experimental medical therapies which were redefined under institutional powers to call them "vaccines") which can only be authorised "Emergency Use Authorisation".
- If we are extending this "State of Emergency" as a means to continue to use up the already purchased Covid-19 "vaccinations" and continue to MANDATE that people are "boostered" in order to be considered fully vaccinated, then this is a travesty and a sign that this is a "BUSINESS MODEL" of the vaccine industry (something that is a direct quote from a leader in that industry). Please remember the vaccines did not give the protection as advised!

# 6. DOES THE QUEENSLAND GOVERNMENT MAKE DECISIONS FOR OUR HEALTH OR TO SERVE THE VACCINATION INDUSTRY?

- The Queensland Government should be a servant of the people. They should not be in business with business people to buy and use up the purchased vaccinations to the detriment of our health, freedom and way of life.
- I and many others are tired of being dictated to by the government which has used these emergency powers to use the power against us and take away our right to cross borders, to talk with our neighbours, to celebrate our personal celebrations, be they weddings, funerals, birthdays, etc. I understand it is difficult to give up power once it is held, but that is exactly what must happen.

# 7. END THE STATE OF EMERGENCY

- There is no good reason to continue with the STATE OF EMERGENCY.
- Allow citizens autonomy over their bodies no coercion to be forced to have a medical treatment.
- I could find many more reasons: such as the impact on mental health of the harsh controls imposed on people by the government under these emergency powers.

- The data is showing far too many adverse reactions to a vaccine that has been rushed and given under this state of emergency – a full enquiry into this must be undertaken and the SOE cancelled immediately.
- Families need to get back to normal life. Our health is a personal choice, taken every time we decide what to put into our bodies.
- If the government really cared about our health then:
  - The government would MANDATE eating vegetables, healthy protein, fruit, organic wherever possible.
  - The government would promote, provide and use approved EARLY TREATMENTS for Covid-19, which are only now being proclaimed by the Main Stream Media as valid treatments. There are more than 10 early treatment protocols which have been used successfully to treat Covid-19 patients from the first strains to the present main variant which is now a mild one stage event (does not progress to the inflammation stage which featured in Alpha, Delta and early strains).
- Therefore, a better option than continuing to create intolerable conditions for the people of Queensland, is to allow Covid to be treated as per other illnesses. Allow the doctor/patient relationship to go back to what it was rather than what we have had since the State of Emergency and that is a Government/patient relationship. The Government is not a medical professional with a doctor/patient privilege that values privacy of information

#### 8. THE STATE OF EMERGENCY IS AN EXCUSE TO TAKE AWAY OUR HUMAN RIGHTS

- There is so much evidence of this e.g. mandates that coerce people to take a medical intervention (vaccines mandates) to keep their job (coercion). These attacks on our human rights have not been fully tested in the courts but it is going to happen.
- Why is the Queensland government doing this when we all "have to live with Covid"? Full disclosure must be given and Enquiries need to be had.
- There are other violations such as from the Anti-Discrimination Act which is under review this week.
