**Dear Committee Members;**

With respect, you all know that you have no basis for extending emergency powers due COVID. I have no doubt that Politicians have an eye on setting precedents for future power grabs – as though Our Constitution should be bypassed whenever politicians desire it.

**NO, NO, NO.** This is an outrageous tyrannical overreach, one that can **in no way be justified by the reality**. This is a fundamental 'watershed' issue and all politicians, Nationwide, must be held to account for the disasters that **they have inflicted** on the population under what was always 'the faux COVID excuse' and because they failed in their primary duty to preserve our Constitutional Rights via the sort of legislation now being proposed once again.

**The Reality:**

The pandemic (scam-demic) was falsely defined by the elite (sic) using false, inappropriate PCR tests and ill defined case numbers which, like politicians enacting emergency legislation, were necessary in order to justify **emergency vaccine approval** by compromised Government drug approval authorities(TGA, FDA) and that occurred despite the new technology being used and the crazy lack of long term data.

Complicit were bureaucratic medico's like Dr Jeanette Young, whose promotion to the Governess role smacks of a reward for corruption. **The Pandemic is finished; there is no justification for any emergency legislation.** (In fact the data has been clear from the beginning - COVID in this country was no worse than a bad flu season with the greatest impact on those **out of the workforce with co-morbidities**.)

The population no longer trusts our Politicians, nor our '2 party' political system. On that basis alone, this bill and all current emergency COVID legislation should be shelved.

**Likewise, ALL COVID mandates must cease immediately and instead** of this proposed Government overreach, if the science can support it, the Government must instead rely on genuine community education regarding personal hygiene and the

science of these experimental gene therapy injections, which again lack long term data, to give due weight to the responsibility to ensure full consent for any medical procedure.

### **The Government has alternatives to this mis-used legislation.**

The data which is 'flooding in' now, emphasises the fact that politicians and the so called emergency legislation cannot be trusted and has only made things shockingly worse. **The criteria to initially enact emergency legislation according to some lawyers, was not** followed, but regardless, the drug companies (whose billions of dollars of potential profit should be matched against its court imposed penalties and corruption) see no such minor (sic) concerns, as an impediment to further emergency drug approval for boosters or whatever else they can bribe the authorities over.

We must return to protecting and promoting our Constitution, individual rights especially to remain in line with the Geneva convention and its derivative Treaties.
