Covid Data - False readings

The information /data that has been used to expand the Covid 19 plus vaccination requirements has never been accurate. All debate about the efficacy and injury rate are closed down, silenced and labelled as scare mongering or misinformation. I would believe more if I saw a program or 2 proving to me that these have been properly investigated.

In the Australian Bureau of Statistics Jan 2022- The death/ mortality rate in Australia has been reduced from the previous year. Covid was the 38<sup>th</sup> in the list. Of the death rates, people have died of or with covid. So, when CHO states that a no. of people have died yesterday the majority of those are presenting with other comorbidities, when tested they have symptoms of Covid which are the same as symptoms of respiratory diseases, even the PCR test has been proven to be unable to distinguish the difference. That is misleading data.

More people died from influenza in 2019 than died of Covid-19 but we did not declare a pandemic, we did not force vaccination on everyone, we did not close business, we did not shut schools. We have learnt to live with these conditions. Each year the flu season is greeted with warnings of how bad it will be, get a flu shot, and stay home if you get it. If it is bad go to hospital. (The people diagnosed with Covid symptoms are told the same thing. Stay home, (no medication required) 7/14 days go back to work. The vaccination programme, rolled out in super quick time- no long-term data to prove its safe only the word of the manufacturer but where is the proof? We are seeing on the TGA website the death rate for the vaccine is almost as high as the death rate from the Covid, but the injury rate is many more times larger. Rare????? serious side effects are occurring. Over 161,000 have reported side effects, over 750 deaths, when is it scientifically accepted that this particular vaccine is a danger to the general

public compared to previous vaccines that are pulled from use after 26 deaths related. Not using Social media, anyone can find reports of patients who were previously healthy happy compliant people, now in wheel chairs( I know of 2) 1 dead 6 days after 2<sup>nd</sup> shot, Know her too, and then video footage of victims with strokes, shakes, permanent heart damage, then it is time to cease with the vaccination program, instil a healthy balanced diet, exercise and rest, as we have done for the last 20 years. To see our elected Government reverse this in Qld is indicative of an overreach, petulance and blackmail to achieve a goal that has never been approved of by the people of Qld. I cannot / couldn't have ever imagined that this current Government would/ have imposed this on the voting public. Removing the choice, forcing the mandate, and blackmailing the business owners into refusal of service to a segment of the community; who do not trust the vaccine efficacy, ( we were never forced to take the flu shot, nor were we refused the ability to work if we didn't succumb and never had to show proof of the vaccine to maintain our job). To refuse people the opportunity to provide for our families (Premiers grandfather maintained the “the most essential thing a family could do was to provide for their family by working a job and bringing home an income” ABC interview with Anastacia in 2017. Where has her integrity gone when she promotes a No Job No job policy and encouraging employers to enforce this. How absolutely disgusting. Morally so wrong in every way. Our local Pub, who did not discriminate has been shut down. We are only a little community; it has affected everyone in the town. The local motel clientele is down, visitor numbers are down, locals have lost their community spirit as it was the local where workers could have a drink together before heading home. Mind you it took a total of 3 trips for the constabulary to travel for 5 hrs for each visit to back up the police here to do that. It included 7 officers on a public holiday 5hr turn around. Crime rates meanwhile in Cairns are soaring because police are enforcing mandates and masks instead of policing. The restaurants meantime are missing out hugely on trade when they need it most to restore their lost income from the lockdowns. When we go out to eat there are usually about 8 in the group. But if 1 does not have the green tick, the event becomes a picnic or a home meal instead of a booking for 8 in a venue who enforces the segregation of society for fear of being fined and closed down including losing a liquor license. How appalling is this segregation. Everyone suffers and for what? The vaccinated are more likely now to be the ones in hospital and the unvaccinated living in leprosy style isolation and degradation according to the Government directives. Why would we want this situation to continue to October? For goodness sake, end the mandates and let's learn to live with Omicron and the next variant will be even milder as it mutates and weakens.

How have we been affected.

I have lost my job. I was a tutor for Ronald MacDonald House after 44yrs teaching. As my manager told me over 50% of Tutors were walking away and she resigned that day. We cannot support the local Café or Pub by going out to meals. Sad but we eat at home or go to friend's houses. I have stopped supporting local shops who are seriously discriminating and will never support those poor souls. They are so blindsided by MSM who refuse to even acknowledge a differing point of view, or held to ransom by AHPRA, including some of my family. We don't talk very much but I hope they maintain their health for many years to come.

Our 23yr old granddaughter with a disability, has taken 5 years to gain full time employment as a teacher aide. She had major spinal surgery at 15 and was told by medical experts that any chemicals in her body would see her deteriorate. She cannot get an exemption so job loss was imminent. However; she caught Covid, was sick for 2 days and has a temporary stay so can work for another 3 months hoping these mandates can end so she can resume her

job long term which she loves and is very committed. A pseudo grandchild 22 yrs old succumbed to the CHO direction of being Jabbed to enter licensed premises. An only child with a fractional family, the relationship has been destroyed with her mother who can only visualise her now as a body laying down. Mother lost her partner in tragic circumstances and never really recovered so her anxiety about her only child is extreme added in to the fact she has lost her jobs as a teacher and as a Social worker.

A 45 yr old teacher training for a marathon had a sudden heart attack 6 days after receiving her 2<sup>nd</sup> jab. That left a class of yr 4/5 with a grief that I have never experienced before.

Lizzie's sister had her 1<sup>st</sup> jab, was unable to walk for 2 months after Pfizer. Weak in the muscles and shaking uncontrollably. July.

On a family basis, our children are great, but siblings are on a need to be spoken to only under necessary as they are so righteous in their following guidelines and as the Government have told them we are selfish and uncaring of the rest of the people. So sad as we were often in contact and a laugh together. Load of rubbish. We are the volunteers, the ones who deliver meals to those in need, to help less fortunate, but the Government does not want us to be recognised as normal community members who have made a different choice based on our understanding and knowledge of our own bodies.

Pro choice not antivax.

Finally, I donot believe that an extension of the Emergencies Act to October 2022 will be in the interests of Qld. I believe that all Mandates are finished with immediately, Society be reunited if that is at all possible thanks to current Government directives, and all jobs should be restored so everyone can contribute to our Australia and Qld State.
