Subject: Formal notification of rejection of the Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022 (Bill)

To whom it may concern,

I would like to formally voice my concern at the Queensland Government's intention to extend the State of Emergency through to October 2022, and strongly oppose the Government's intention.

My reasons for strongly opposing this extension of powers are:-

- irrespective of what side you sit on, there is no deadly pandemic in Australia,
- there are studies that now show vaccinated people carry as much viral load as an unvaccinated person. This is clearly evident when Queensland borders were opened in December 2021 to Vaccinated people only and the numbers of cases rose significantly,
- the Australian Bureau of Statistics show COVID-19 was the **38th** leading cause of death yet the Queensland government has closed borders, shut down businesses (some permanently), caused segregation in society and families, some of which may be irreparable,
- during the first year (2020) of this 'pandemic' there was a **decrease** in mortality in Australia,
- Heart disease, cardiovascular disease and diabetes caused **more** death than Covid-19, however the Queensland government still allowed the sale of cigarettes, didn't ban sugary foods or drinks and allowed fast-food businesses to operate while healthy food outlets were forced to shut,
- The Queensland government invested vast amounts of tax-payer money into 'vaccine' marketing saturating the media, highway signs, etc when they should have been targeting and promoting healthy eating and exercise, which would have assisted vulnerable groups in our society to have stronger immune systems to fight viruses,
- mental health issues as a result of the mandates and lockdowns/restrictions are a major concern and should be more of a concern to the Queensland government,
- there are studies to show that **natural immunity IS** better than vaccine immunity (which is proven to wain), and most Queenslanders would have had the Omicron variant or come into contact with someone who has,
- there are many studies that now prove Sars-CoV-2 should now be treated as an endemic,
- children do not need to be vaccinated against this virus – there is proven studies that show children have an extremely low chance of being seriously affected by this virus. And there is **NO** long-term data on the side affects of these 'vaccines',
- there are studies to show that masks do not filter out the virus, however they can impact a person's health and also toddler social progression. There are zero independent studies that show masks are effective against Sars-CoV-2,
- there are studies proving the lockdowns do not work and it's clear to everyone they don't stop the spread of virus,
- the mandates and restrictions are discriminatory against people who have chosen not to take the trial injection and are a violation of people's rights,
- the experimental injection that has been called a 'vaccine' does not do what a vaccine is designed to do, however there is international documented evidence of injury and death attributed to these 'vaccines',
- the 'vaccine' mandate has caused enormous hardship and pain to those who were forced to quit or were fired for their choice not to take the experimental injection as well as to their families. This is now having a damaging flow on effect on our health system

where there are major staff shortages because of the government request to isolate. However, the government is also allowing non-symptomatic, positive Covid staff to work and treat patients when negative tested, non-vaccinated staff are not allowed to return to work. The public who are sick are paying the price for this,

- People who have survived two years of this virus and are unvaccinated against Covid-19 are being segregated and discriminated against just because they are weary of an experimental injection that has injured and killed hundreds of thousands of people,

With the enormous amount of data and evidence available to the Queensland government, the extension of powers is **not warranted** and the Extension of Expiring Provisions) Amendment Bill 2022 should **NOT** be passed.

The people of Queensland have suffered enough – not from the ‘pandemic’ but from the harsh, non-sensical, illogical and unwarranted restrictions and discrimination we’ve endured. Most countries across the world have now lifted all restrictions and emergency powers because of the overwhelming evidence the pandemic has passed. Australia needs to do the same! There is too much data now to ignore, Queensland needs to lead the way in Australia in lifting all restrictions.
