Dear Committee Secretary,

I strongly oppose the extension of the State of Emergency in Queensland or anywhere in Australia.

The Queensland State of Emergency measures must still abide by the Federal Law, adhere to our constitution and the Quarantine laws, and quarantining healthy people without a court order is in breach of the Federal Biosecurity Act 2015.

Fundamental Human Rights are also in breach:

- **ARTICLE 3 HUMAN RIGHTS** Human dignity: human rights and fundamental freedoms are to be fully respected (and the) interests and welfare of the individual should have priority over the sole interest of science or society.
- ARTICLE 5 AUTONOMY The autonomy of persons to make decisions ... is to be respected.
- ARTICLE 6 CONSENT Any preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned (and) ... may be withtdrawn by the person concerned... without disadvantage or prejudice.
- ARTICLE 9 PRIVACY The privacy of the persons concerned and the confidentiality of their personal information should be respected. To the greater extent possible, such information should not be used or disclosed for purposes other than those for which it was collected or consented to, consistent with international law, in particular international human rights law.
- **ARTICLE 11 NON-DISCRIMINATION** No individual or group should be discriminated against or stigmatized on any grounds.
- **ARTICLE 18 DECISION-MAKING** Professionalism, honesty, integrity and transparency in decision-making should be promoted, in particular declarations of all conflicts of interest and appropriate sharing of knowledge.
- **ARTICLE 18 PUBLIC DEBATE** Opportunities for informed pluralistic public debate, seeking the expression of all relevant opinions, should be promoted.
- The Nuremberg Code The voluntary consent of the human subject is absolutely essential... the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of

- the elements of the subject matter involved as to enable him to make an understanding and enlightened decision.
- **s51** (**xxiiiA**) **of our constitution** clearly states from the 1946 referendum that no medical or dental be forced upon the people of Australia, and was upheld in 1996 Breen & Williams HCA and Wong v Commonwealth HCA 2009.

A health emergency must be backed up by evidence of an emergency, and the health authorities have admitted inflating the death toll by cases other than Covid. PCR and Rat Tests have been inconsistent, the mask mandates are easing up on March 4 2022, and Passport mandates are being abandoned in many European countries including the UK.

On 22 February 2021 Greg Hunt publicly admitted that the vaccine is a world wide experiment. I do not consent to being part of this experiment.

I demand that the State of Emergency in Queensland and Australia are removed immediately.
