To whom it may concern,

My name is Katie Burgess. I live at [REDACTED]. My phone number is [REDACTED]. I am writing to you to voice my objection to the Extension to the Emergency Bill (until 31st October 2022). I am a Kindergarten Teacher who has spent 16 years teaching, getting children socially and emotionally ready for the school system and prep in QLD schools. Over the 16 years, I have taught approximately 40 children per year, totalling 640 students approximately. This has made a big impact to children and their success at school. Due to the mandates and my choice not to participate in the clinical trial of testing Pfizer, AstraZeneca, Moderna or Novavax, I no longer can teach. I now label chemical bottles in a factory that doesn't discriminate against my medical history to complete my job. Since working in the factory, I am treated better, paid less per hour, not having to spend my own money or time to complete my job, and able to leave mid shift if needed for any reason. Even if the mandates are revoked, I will not be returning to teaching. This control you have put on our ability to complete our jobs has not only ruined future children who will never get taught by a Bachelor qualified teacher (as we all know there is a massive shortage. My position has not been filled or anyone has applied as there isn't anyone looking), but you have strained an already struggling industry.

Covid has been a gateway for the Government to create a dictatorship. You have turned people against people over a medical trial. You have hurt the tourism industry, recreational industry and all small local businesses by telling people who can and can't walk inside venues. You have inflated Covid figures to support your narrative that the government is trying to "help" the people, when all you have done is hurt the economy and made the struggling individual, struggle even more with inflated fuel prices, rental prices, food prices and living costs.

My son is 16 and is currently studying at school in year 11 his certificate in food operations. He will leave school as a qualified chef. He has read the information that the government, protesters, doctors and mainstream media have all delivered and has decided that he is healthier without a trial drug in his body. This means his career that he is studying for he will not be able to use as he won't be jabbed. These mandates and the extension of this bill is crippling the country. We are no longer supporting the leaders of tomorrow, you are scaring people to conform and making people look like criminals for not following the herd.

I plead to you to end this madness. Stop the extension. Many other countries are 'living with covid' now, they don't treat people poorly for not having the 'jab'. A class of 16 babies aged 15 months to 2 years then needed to all get tested for covid along with every staff member in that service. How is that protecting the children? A fully 'jabbed' educator could bring covid into a service and expose it to all those children at such a young age who then had to be tortured by sticking a swab up their nose? You really don't need to be educated to see that that doesn't make any sense!

The current flooding situation, you can't be an SES volunteer unless you are 'jabbed'. Really?!? I implore you to go on youtube and search up Australia covid and see how the rest of the world sees us. We are the laughing stock in the world! We look like we're being controlled by Hitler with 'wellness camps' (concentration camps) and vax venues and non-vax venues. New Zealand is also treating their people in the same demoralising way.
