I sincerely ask you to help stop the Covid emergency declarations and associated measures and mandates. The community is hurting and I am hurting. I am experiencing isolation, rejection, judgement & persecution due to the governments mandates. I am being treated for resulting depression & anxiety due to the Governments unjustified, cruel & I believe illegal mandates. I am not permitted to participate in society. I am not allowed to attend the charity clubs that I am a member of. I am not permitted to do charity work, to help raise funds for underprivileged children for their schooling nor to help them with tutoring after school. I am excluded from all cultural activities. I am excluded from attending physical exercise instruction & from yoga which I need very much for my Physical & mental health.

My heart goes out to all those Australians who have suffered from the Govt's mandates & restrictions with loss of jobs, income, businesses, family contact & support, friendship, needed medical support, the break up of relationships & marriage which has also led to suicide. I am in despair. So many people have expressed 'what is there worth living for'.

I am tired of it, we all are & it is making me sick physically & mentally. The lockdowns and border closures which separated us from our loved ones will be remembered as one of the greatest policy failures of our time. The Australian Bureau of Statistics documents that in a 22month period 273,901 Australians died. Only 2,639 were Covid related & 92% had 3 serious underlying conditions. Covid deaths only represented 1% of total deaths over the past 22 months & the average age was 81yrs for men & 86 for women. In a 22month period 2,639 covid related deaths & in a 12month period in 2019 4,429 deaths from the Flu.

These stats are on the ABS website. The stats on the ABS sight also show there has been more contageon amongst the Vaccinated than the unvaccinated showing that the mandates have been unnecessary,destructive & ineffective.

I implore you to please help stop the covid restrictions and mandates or soon the Australian public will lose all faith in their institutions (medical, legal, political) and this faith will never be recovered.
