To whom it may concern,

I am writing today to express my position on the extension to the Emergency Bill until the 31st of October, 2022. I am against any further extension of emergency powers or amendments to increase those powers to emergency officers and the Chief Health Officer for the following reasons.

- Vaccine mandates should never have been introduced and have caused more harm to the health and wellbeing of people than the virus. They have also affected the economy and small businesses, caused huge problems with staff shortages across many of our essential services like nurses, police, teachers, doctors which further puts people's health at risk.
- The moral impact of human rights violations due to the mandates needs to be addressed. When you threaten people's livelihoods and ability to support their family and provide for the needs of their family it is a huge breech of human rights. No job, no jab is not ok! People have the right to body autonomy and to choose what medical treatments they deem fit to take instead of taking a treatment that could potentially harm them or kill them.
- Alternative , safe and effective early treatments have been ignored and banned in favour of a "vaccine" that has a range of adverse effects that people cannot be fully informed about due to the massive censorship of information and vaccine companies not being transparent with what is in the vaccines and what the long-term effects may be. There is building evidence that people are suffering from myocarditis, bals palsy, nervous system problems and the list goes on. Children are even having strokes not long after their shots, this is very concerning.
- Mask have not been proven to be effective as we have been wearing them for months now and the numbers of covid cases rises. Forcing children and adults to be breathing in Carbon dioxide for hours every day is not healthy and has been shown to reduce the effectiveness of the immune system to fight of viruses.
- Government claims we are around 80 90% vaccinated yet the covid cases still rise. It seems that since the forced vaccinations the number of cases and deaths have risen which to me sparks concerns about just how safe and effective such vaccines are and why they are continually being forced onto people when TGA and VAERS are fully aware of the large numbers of adverse reactions and deaths that have occurred because of this. Although I agree that every death is tragic; the latest data from the Australian Bureau of Statistics puts things into perspective. Over the past 22 months of Covid, 273,901 Australians have died; however, out of these deaths **2,639** people were covid related with 92% of these having serious underlying medical issues. Some 100,00 people died of cancer, 32,000 died of heart disease, 30,000 died of Alzheimer's and Dementia; and 10,000 of diabetes. Covid related deaths represent fewer than one percent of the total deaths in Australia over the past 22 months. The

median age of Covid related deaths was around 81 years of age for men and 86 years of age for woman, which happens to be the national average lifespan. Far more people were dying of flu than Covid. Over a 12 month period in 2019 for example 4, 124 people died of the flue compared to the last 22 months (Close to 2 years) where 2,639 died of Covid yet extending emergency powers, putting in mandates and passports seems a justified response.

- Discrimination and segregation that has occurred within our communities has increased due to these mandates and passports causing riffs between family, friends, fellow human beings and has cause damage to businesses and job security. This division and discrimination is wrong, it was wrong when people did this to coloured people, it was wrong when it was towards women, and it is wrong now.
- We live with flu viruses all our lives, most Covid cases are mild and are treated at home same as any other flu. Those who have been needing hospitalisation are usually ones who have had underling health issues or are elderly. So why the aggressive and violating mandates?
- Despite restricting the unvaccinateds movements and exiling them from society, despite wearing masks all day long and social distancing the virus has continued to spread. So how can these methods be justified in their use. It is clear they are not working and cause more harm than good. If unvaccinated can't go places, are being kicked out of work and numbers are still rising then who is spreading the virus and why has the case numbers jumped up so high since forced vaccinations have come in. These are issues that need to be addressed.

The only pandemic that seems to be is one of the human right violations, discrimination and fear mongering for a virus that had a 99% percentage recovery rate, mostly mild flu symptoms and less than 1% death rate. This is no reason to be extending emergency powers and enforcing harsh and immoral processes on the community that does take into account their health or wellbeing. In reality we need to be learning more about keeping our immune systems healthy and moving on with our lives.

The amount of tax payers money and public resources that have been wasted to police businesses and enforce these mandates has been destructive and ineffective to people and our communities. We should be looking at educating people on their immune systems, proper hygiene, investing in better health care especially for the elderly and vulnerable that does not infringe on their human rights. Looking into safe and effective early treatments and services that everyone can access.
