I DEEPLY OPPOSE AN EXTENSION TO EMERGENCY BILL as we have lived oppressed long enough. It is a known fact that the Covid Statistics are exaggerated, including the decline in flu statistics in the past 2 years.

The death tolls have been grossly over reported, with the TGA and CDC admitting that only 8.6% and 6%, respectively, of COVID-19 deaths could be solely attributed to the Virus.

I have lived in Queensland my whole life. My late Father was in World War 2 & fought for our Freedom. My Uncle fought in WW2, POW, then KIA in Korea.

\* My terminally ill Mother could not be visited in hospital by healthy, non-covid loved ones recently. She was also shoved into a Covid ward at Townsville University Hospital as there were no lung ward beds. She had no covid & there were others in there as well. She was in there for 5 nights. Her immediate family live over an hour away & were not allowed to visit her as she was in a Covid Ward (without Covid, but because you have opened up so many wards for Covid for the expense of others). My Mother felt very isolated & alone for no reason. She was treated as Public for the entire 12 days she was in Ingham & Townsville Hospitals as she was told Private rooms are reserved for Covid. DVA was billed for Private Care which is disgraceful.

\* My 88year-old Father-in-law has not been seen by his son, or myself, for most of the time these mandates have been in place, as he is in a Nursing Home an 1 hr away. We can no longer see him now. This gentleman should be declared as end of life as he has Advanced Dementia (even though he recognises us & use to perk up when we went there). His 85year-old wife used to visit him every day, but doesn't because the Government says elderly shouldn't socialise.

\* I have been told by my prominent GP that un-vaxxed will not receive pap smears.

\* I have been told by Mental Health Clinician that un-vaxxed won't receive face to face consults one month & then the next told you can. They really don't know.

\* I know of GP Surgeries who are charging un-vaxxed at least \$70 surcharge for consult with only \$30 back from Medicare. They say it is for PPE. Same places, un-vaxxed have to enter back door & seen in unairconditioned storage room or outside.

\* I live in a regional town & know of takeaway businesses who choose not to serve un-vaxxed customers, even if they are not dining in, including an 80year-old gentleman who was trying to get his dinner.

\* My niece was sacked from her Bank job for no good reason, apart from not having the vax.

\* I do not know a single person who is un-vaxxed that has had Covid. I know quite a number who are vaxxed that have been diagnosed as having Covid19, the majority with mild symptoms, none hospitalised.

\* I have a close friend, who either had it twice in 1 month or had long covid symptoms. She was only vaxxed due to job mandated. Her un-vaxxed partner, 14 years her senior, who sleeps in the same bed, never had it. Please let all Queenslanders get back to our lives, jobs & loved ones. Let us be free again.
