The Health Minister, Yvette D'Ath, tabled a new Bill last week that seeks to extend the Queensland's Emergency laws for another six months. Under the Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022, Queensland's 'state of emergency' laws will be extended from 30 April 2022 to 31 October 2022. I am writing to oppose this bill and any extensions to these emergency provisions.

The Elimination Approach has Failed

When the Honourable Yvette D'Ath tabled the Bill, the Public Health and Other Legislations (Extensions of Expiring Provisions) Amendment Bill 2022, she stated that, "We all hoped that Covid would soon be over," when the 'pandemic' began. Maybe that was false hope. Does anyone ever hope that Influenza would soon be eradicated? This was a false hope. The elimination objective was doomed to fail from the beginning. Now our hope is that the overreach of the Qld. Government mandates will soon be over.

The elimination approach mentioned by the Health Minister in her speech, was a mistake. The Qld Government should acknowledge this and adjust their approach accordingly, to follow true science, not Fauci science or D'Ath Science. Such approaches such as those

outlined in the Great Barrington Declaration¹, like Focused Protection², should have been investigated and implemented to have a multifaceted approach to early treatment to prevent hospitalisation and death. The Barrington Declaration is now an old document. Even more up-to-date research has been conducted, but it seems the Western Governments of the World are united in silencing and ignoring the relevant research.

Full Capacity?

The Health Minister stated that 'contact tracing requirements have reduced and businesses are now once again operating at full capacity'. This is a nice, positive statement but offered without any evidence. What research has been done to back up her statement? How many businesses have closed down due to the mandates, lockdowns and restrictions? The Health Minister might have meant to say some businesses are operating at full capacity, but only those who managed to stay afloat, and only those who are not still struggling to make ends meet. Why paint a rosy picture? Surely this is not calculated to lull us into a false sense of security so that we will gladly give away our freedoms to a Government who has been less than truthful?

Omicron

The Health Minister also remarked that Omicron can spread rapidly, and I agree with this statement. However, the current vaccines do not provide immunity to Omicron or any future strains of the virus. The vaccines do not provide immunity. The current vaccines do not prevent the spread of the virus. Natural immunity can.

Power Grab

This Bill is a power grab. When governments increase their power and control, they do not let it go until they are made to. That is why there have been numerous extensions. If we give in to this request for another extension, they will just keep taking more and doing more harm with that power.

Nonsensical Abuse of Power

What is the reason stated for requesting such power? To enforce such things as mask wearing. Interesting!! Masks do not prevent the transmission of viruses. Read the label on the packet from the manufacturer. It is nonsensical to require healthy people in cars, in work places, shops, restaurants, cafes, gyms etc to wear a mask for the purpose of preventing transmission of a virus when a mask can't actually prevent the transmission of a virus.

Unethical abuse of Power

It is not only nonsensical, but it is also unethical to require people in a free society to wear a mask that can't do the very thing that it is being stated it must be worn for; ie. the prevention of the transmission of a virus. It is unethical to require people in a free society to hide their faces, their smiles, their lips. It dehumanises people, reduces effective

These nonsensical and unethical requirements are actually causing harm. And yet, the Honourable Yvette D'Ath is asking for more power so that she can continue to inflict more harm on the subjects of Queensland. We have had enough of this kind of help, thank you very much. We've had enough harm inflicted on our health and wellbeing justified in the cause of our health and well-being.

Enough nonsensical health mandates.

Enough unethical and harmful health requirements.

We don't believe you anymore, Minister. Why would we give you more power?

Abuse of Power

The most disturbing example of this nonsensical, unethical and harmful abuse of power can be seen in the way the Qld Government has acted in the medical response to Covid 19, including:

- withholding cheap, safe and effective early treatments for Covid 19
- preventing doctors from administering effective early treatment protocols for Covid 19
- threatening doctors with negative consequences if they ignored these insane directives and actually treated Covid 19 patients with cheap and effective medications
- insisting people go home and wait until they are really sick and then come back to hospital where they can then be treated with a medication that is overpriced and almost likely to kill you, and put you on a respirator and let you die in isolation away from your family and loved ones.
- hospitals being financially incentivised to record all deaths as Covid deaths
- insisting on PCR Testing when PCR tests cannot legitimately be used to correctly identify Covid 19
- terrifying the public with daily case numbers that were not accurate because PCR testing is unreliable for accurately identifying Covid 19
- insisting that experimental vaccines are the only possible course of action
- hiding negative side effects of the experimental vaccine from the public
- coercive action to manipulate people into putting a toxin into their body or lose their job, or right to associate, or travel.

Ignoring the Nuremberg Code

Australia is a signatory to the Nuremberg Code. Whenever any experimental medical procedures/treatments/vaccines are employed, patients must have the right to bodily autonomy. They must have full disclosure of any possible known negative consequences. This is what informed consent is. They must know in advance the potential risks in order to make their informed choice. Whenever a negative consequence is experienced, the trial is to stop. The information is meant to be shared and added to the list of possible negative consequences and then shared with any new patients considering joining the trial. The

patients must be monitored and accurate records maintained. A placebo group is essential for the test to be valid. These basic procedures have been ignored and run rough-shot over, so that the medical profession is no longer trusted. In fact, every vaccine developed in the last 50 years must now be treated with scepticism. Maybe those antivaxxers were right all along.

Hostile Take Over

Why were these basic procedures ignored, discouraged and evidence hidden, not just in Queensland but across the Western world? There has been a united response to Covid around the globe. The consistency of the language and the response smells like a predetermined Blueprint.
