## Dear Secretary

I am providing my voice here to state that I DO NOT consent to the extension of emergency bill.

The reasons I do not agree to this are the exaggerated statistics provided for covid related deaths in ABS data provided and a vast underreporting of vaccine side effects and injuries especially to the public via the media. Also not granting medical exemptions to people who need one or allowing those who have one to return to work such as in education or prisons is beyond comprehension. People who are in their 80s and 90s with Covid is NOT a valid statistic that can be used to validate vaccinating healthy children for an illness that is not a risk to them.

There has been no Chaplaincy team or volunteers to run breakfast club for the children or the lunchtime programs we ran for social and emotional support.

It makes no sense at all why unvaccinated staff are not allowed on premises even to say goodbye or visit but unvaccinated parents are - if it was truly about health this would not be happening.

Our children lost many key staff at their school and have in senior years often been without a teacher. Please reinstate teachers and school staff and return the right for vaccination to remain a medical and private choice as it should be between a person and their doctor.

There is absolutely no proof that the covid vaccinations prevent Covid (the actual definition of a vaccine is that it is supposed to prevent you getting an illness).

Almost every vaccinated person we know has had Covid now and many who remain unvaccinated remain Covid free or if they have had Covid it's been no worse than those that are vaccinated.
