I am writing to give my reasons for the Public Health and other legislation (extension of expiring provisions) Amendment Bill 2022 NOT BE EXTENDED PAST THE 30/4/2022 DATE.

MY REASONS AS FOLLOW.

1. When these mandates were enacted there may have been some uncertainty in what measures be taken in the COVID 19 situation.

NOW THE GOVERNMENT ABS STATISTICS REPORT IS OUT THE FIGURES SHOW THE TRUE NATURE OF THE PANDEMIC AND IT'S OUTCOMES.
