Re: Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022

Please note my interest and point of view of this Government's reaction to Covid19.

There should be NO extension of the BILL.

When these Emergency powers were brought forth into the QLD legislation they were done without due diligence and quite frankly illegally under the Federal Government laws.

They enabled this Qld Government to control the narrative and without freedom of speech or even so far as not allowing the citizens to have the ability to question and research any issue without being labelled a Conspiracy Theorist.
