## Re: Proposed extension of the State of Emergency Powers

I am writing in absolute opposition to the extension of the Queensland Government's State of Emergency Powers. Over the past two years, these decisions made by the government under these SOE powers have destroyed many businesses, caused division and segregation within our communities, caused many to lose their livelihoods due to exercising their human rights of body autonomy, and caused an astronomical increase in mental health issues and suicides.

Personally, I know people who have been under severe financial strain because their businesses had to close under the lockdowns or they have lost their jobs when others had to lockdown their businesses. I have known many people, including family members, who have suffered from the COVID illness and recovered fully regardless of whether they were vaccinated or unvaccinated. I know five people who have experience severe adverse reactions to the vaccines, being hospitalised due to its effects. I know many people who have been stood down from their jobs, losing their livelihoods, because they do not consent to being injected by an experimental drug. I have seen numerous papers from internationally renowned medical experts which prove beyond a doubt that: a) COVID in and of itself causes long-term impacts or death in an extremely small percentage of cases which does not warrant declaration of a "SOE"; b) the PCR tests upon which "COVID" cases are 'proven' is highly inaccurate and not fit for purpose; and c) the experimental vaccines are causing millions of severe adverse reactions and deaths. There is no justification for an extension of the Queensland Government's SOE powers. In fact, they should be scrapped immediately. It is my personal belief that all in power should and will be held accountable for the irreparable harm they have caused to the people and communities in our beautiful state.

The measures that have been instituted by the Queensland Government under these powers have consistently broken federal and international laws including the Federal Biosecurity Act 2015, s51 (xxiii A) of the Constitution, and the Nuremburg Code. Greg Hunt, Australia's Health Minister, in February 2021 publicly announced the vaccine is a worldwide experiment. Through the measures mandated by the Queensland Government, people are being emotionally coerced and financially blackmailed into partaking in a scientific experiment without informed consent, which is against human rights in Australia, s51 (xxiii A) of the constitution, the Nuremburg Code, and many other laws within Australia and internationally. Under s51 (xxiiiA) of the Australian Constitution, no medical or dental treatment can be forced upon the people of Australia; this was upheld in 1996 Breen & Williams HCA and Wong v Commonwealth HCA 2009. The mandates are clearly designed to threaten people into receiving the injections. This is coercion and should not be legal.

It is my firm belief, based on fact, that there is in fact no State of Emergency in Queensland. In fact, between 01 January 2021 and 13 July 2021 one person died from COVID and yet the Queensland

Government extended the State of Emergency twice without there being any evidence of a state of emergency. The government has been relying on false data from PCR and RAT tests, which are inaccurate to say the least. The PCR test clearly was never designed for what it was being used for. The inventor of the PCR test said it cannot be used as a diagnostic tool and anything over 27 cycles will give false results; in Australia the PCR tests are often run at 40 cycles. It is clear the PCR testing has been used to manipulate the public and keep them in a state of fear. There is no real State of Emergency. The government has instead pushed constant messages of fear and discrimination based on misleading claims including: the virus will hunt down the unvaccinated; we would be safe only if we get vaccinated; the government will chase down everyone who is not yet fully vaccinated; now only a booster/third shot will keep you safe.

Statistics demonstrate that this is a pandemic of fear, not an actual pandemic. During the past two years, less than 1% of the total deaths in Australia were caused by COVID. Far more people died of cancer, heart disease, diabetes and dementia. Of the roughly 5000 deaths in Australia attributed to the disease, it has been clearly proven that the majority of these people died *with* COVID and not *because of* the disease. Nearly all of these people had other more serious underlying health conditions which killed them. The average age of death of people with COVID is 81 for men and 86 for women; both of these statistics are above the national life expectancy. Before COVID, more people died annually from the common flu. It is proven fact that since the uptake of mass vaccinations, COVID cases skyrocketed across Australia. Unvaccinated people in Queensland have not been able to attend most venues, yet these are the exact places where the virus has been spread among the vaccinated. It is clear that the so-called vaccinations do nothing to stop the spread of the virus or the ability of a person to contract the virus.

Across Queensland, many industries have lost some of their best and brightest because they are exercising their human right to not inject an experimental substance into their bodies. Highly trained and experienced doctors, nurses, teachers, counsellors and many others have been stood down, without pay. All people suffer when these professionals are not longer able to provide their services and expertise. Childcare workers and teachers were already in high demand; now there are critical workforce shortages because of the Queensland Government mandates introduced under the current State of Emergency. Resources have been wasted policing these mandates and businesses have paid the price of losing customers. Instead, we should be investing in protecting the sick, disabled, frail and elderly <u>not</u> introducing useless measures which negatively impact on the rest of healthy Australians who have minimal risk from having the virus.

End the State of Emergency powers. Stop all mandates. Let Queenslanders live and thrive again.
