Subject: STOP any extension to the Emergency bill Date: Friday, 4 March 2022 11:07:50 AM

I DO NOT want an extension to the Emergency bill.

I DO NOT support the Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022 (Bill), which will allow the State of Emergency in Queensland to be extended until 31 October 2022.

The recent release of the <u>COVID-19 Mortality in Australia | Australian Bureau of Statistics</u> (<u>abs.gov.au</u>) (January 2022) data provides evidence of the real statistics of Covid19 deaths that have been inflated by governments and mainstream media.

The data states that 273,901 Australians died between March 2020 until the end of January 2022.

There were 2,639 Covid19 related deaths in this period.

In the same period 100,000 Australians died from cancer, 32,000 from heart disease, 30,000 from Alzheimer's and dementia and 10,000 from diabetes.

Of these deaths, only 0.9% actually died of Covid19 and the median age of death of those who died of Covid19 was 81 for men and 86 for women, both of which are above the National life expectancy.

Our governments talk about 'following the science' and the 'facts.' Well, **here are the facts**, uninflated and without the sensationalism of the mainstream media. IT'S TIME TO START FOLLOWING THE FACTS.

In December 2021, a judge ordered Pfizer to release documents concerning adverse events from their Covid19 "vaccine," which Pfizer fought to have concealed for 55 years. The very first release of 500 documents contained information entitled, "Cumulative Analysis of Post-Authorisation Adverse Event Reports." The document revealed that within 90 days after the Emergency Use Authorisation release of Pfizer's mRNA vaccine, the company was already aware of voluntary adverse reaction reports that revealed 1,223 deaths and a total of 158,000 adverse reactions. And yet, despite this information being released, the government and mainstream media were silent, neglecting to report these findings and continuing to peddle Covid19 "vaccination" as "safe and effective" and the only way out of this pandemic.

Bill Gates, one of the main investors of the Pfizer vaccine, openly declared at the Munich Security Conference in February 2022: "Sadly, the virus itself – particularly the variant

And now children are being targeted with a vaccine with little to NO efficacy, despite children having an almost non-existent Covid19 Fatality Rate (CFR). As at 3 March 2022*, in the 0-9 age group, there has been 209,996 cases of Covid19 reported.
