Dear Sir/madam,

I would like to voice my concern about extending the Qld State of Emergency. While I initially supported the lockdowns and restrictions put in place when COVID first arrived here in Australia, to ensure that the Qld health system wasn't overwhelmed, it was soon clear that the continuing state of emergency wasn't justified at any level .

My reasons are as follows, in no particular order:

- COVID-19, especially the Omicron variant, is not much worse than the common cold, having approx. the same effect on the population as the seasonal flu. Only people with multiple comorbidities, especially the elderly, need to take more precautions. The general population has little to fear from COVID-19
- There has been severe censorship from mainstream media, including Facebook & Google as well as local news outlets, of the following
  - o Non-mainstream scientific views re the efficacy of the current vaccines (E.g. See the recent statement by French professor Christian Perronne <a href="https://doctors4covidethics.org/strong-and-clear-statement-made-by-professor-christian-perronne/">https://doctors4covidethics.org/strong-and-clear-statement-made-by-professor-christian-perronne/</a>)
  - o The severe reactions to the COVID-19 vaccines, including death (for more on this see Senator Gerard Rennick's FB page <u>Senator Gerard Rennick | Facebook</u>). And the severe reactions are not only affecting the elderly but athletes (see <a href="https://www.youtube.com/watch?">https://www.youtube.com/watch?</a> reload=9&app=desktop&v=onPR0E5WIAg&feature=share)
  - o Alternative successful treatments, such as Ivermectin, Vit D, Vit C, Zinc, etc

Where there is censorship, we need to be asking "what are they trying to hide?" This should be raising many red flags. Are they just pushing the fear campaign and continuing the state of emergency because they have a vested interest in it continuing

- The original case, hospitalised & even death numbers worldwide were hugely inflated, mainly due to the flawed PCR tests that was providing mostly false positives. These PCR tests were configured to list any trace of COVID as a positive case (see <a href="https://www.vaccinationdecisions.net/the-who-declares-australias-pcr-test-results-to-be-100-false-positives/">https://www.vaccinationdecisions.net/the-who-declares-australias-pcr-test-results-to-be-100-false-positives/</a>). It is unknown whether the PCR tests have been recalibrated to provide more realistic case nbrs. Also, at least in the US, hospitals were given financial incentives to list anybody who died with a (probably false) positive case as having died because of COVID
- mRNA vaccines (e.g. like Pfizer & Moderna) have never previously been successful in treating diseases such as COVID-19. They've never got beyond the animal trial phase because all the animals died. With these current COVID-19 vaccines, the animal trial phase has been bypassed. This is unheard of in the vaccine industry. Normally vaccines take years to get to market
- There are currently proceedings in the International Criminal Court against certain individuals, including the CEOs of Pfizer & Moderna, relating to numerous violations of the Nuremberg Code as a result of the COVID-19 vaccine rollout. Until these proceedings play out, the state of emergency, including all vaccine rollouts, lockdowns, quarantining, mask mandates, etc, should be at least temporarily stopped (see <a href="https://www.thedesertreview.com/opinion/columnists/gates-fauci-and-daszak-charged-with-genocide-in-court-filing/article-76c6081c-61b8-11ec-ae59-7718e6d063ed.html">https://www.thedesertreview.com/opinion/columnists/gates-fauci-and-daszak-charged-with-genocide-in-court-filing/article-76c6081c-61b8-11ec-ae59-7718e6d063ed.html</a>)

- The hugely negative effect the state of emergency with resulting restrictions have on businesses and people, including their mental health, is far greater than any negative effect from COVID itself
- We have to learn to live with COVID, as we have learned to live with many other viruses. The vaccines do not stop people getting the virus nor passing it on, just temporarily reduce the symptoms. In fact, the efficacy of the vaccines wanes seemingly after a few months, especially with each new variant, which means that multiple regular "boosters" will be required. Even then the boosters don't seem to be doing anything. For example, Israel, which is one the most vaccinated places in the world with approx 98% of population having at least 3 jabs, has currently a huge spike in infections (see <a href="https://graphics.reuters.com/world-coronavirus-tracker-and-maps/countries-and-territories/israel/">https://graphics.reuters.com/world-coronavirus-tracker-and-maps/countries-and-territories/israel/</a>)
- It seems that most people in hospital "with COVID" are actually vaccinated, with at least 2 shots
- Is it appropriate now to be continuing with restrictions and enforcing more vaccine mandates just as other countries such as the UK are starting to relax them?

It is my hope that the State of Emergency is NOT extended
