

RE: PUBLIC HEALTH AND OTHER LEGISLATION (EXTENSION OF EXPIRING

PROVISIONS) AMENDMENT BILL 2022

I would like to submit my response to the proposed bill to:

- further extend the operation of essential public health measures implemented to facilitate Queensland's response to the COVID-19 pandemic
- extend amendments to the *Corrective Services Act* 2006, *Disaster Management Act* 2003 and *Mental Health Act* 2016 to support the public health response.

Based on a substantive body of evidence, I believe that such an extension is unnecessary, illadvised, unjustifiable and would be damaging to Queenslanders already severely impacted by two years under a State of Emergency. I provide evidence to support my position that there is no reason for the temporary pandemic and emergency measures to be extended.

The proposed bill for a virus that has shown over 12 months to have a CFR (Case Fatality Rate) of 0.1% for those under 60, with 71% of people who died of/with COVID having underlying health conditions according to the ABS, here: <a href="https://www.abs.gov.au/articles/covid-19-mortality-2">https://www.abs.gov.au/articles/covid-19-mortality-2</a> - makes the extension measure, especially with the event of Omicron, unjustifiable.

3) Emergency measures such as vaccination mandates because of the claim of safety and efficacy are fallacious: COVID vaccines are not proving to be either safe or effective. Of note: every single infection in QLD was brought in via vaccinated individuals. Therefore, the vaccines were ineffective at preventing transmission.

Vaccine mandates were ill-advised and damaged people's lives, health and the economy. See articles attached.

Many countries around the world have now dropped their COVID19 emergency measures due to COVID19 becoming endemic. Currently the UK, Denmark, Norway, Sweden, Iceland and others have no more emergency measures in place. The NHS vaccine mandate in the UK was reversed due to pushback by more than 80,000 doctors, nurses and healthcare workers who had first-hand experience of both risks and benefits of COVID19 and of the vaccine as a 'public health emergency response,' and who worked through the Alpha, Delta and Omicron waves without vaccines.

In 2021, just as Queensland brought in vaccine mandates for educators and divided society along vaccinated/unvaccinated lines, Pfizer's initial trial data was released by the FDA after a ruling by the USA Supreme Court. The FDA wanted that data hidden for 75 years, but their request was overruled.

Pfizer's early trial results on Adverse Events show that:

As of February of 2021 there were:

- -over 1,200 reports of death;
- -tens of thousands of reported adverse events;
- -23 cases of spontaneous abortions out of 270 pregnancies and more than 2,000 reports of cardiac disorders.
