I and many in my social circles, **DO NOT AGREE** with this move. **THERE IS ABSOLUTELY NO BASIS FOR THIS EXTENSION BASED ON ALL THE DATA THAT HAS RECENTLY COME TO LIGHT. I THEREFORE URGE YOU TO NOT MAKE THE MISTAKE OF EXTENDING THIS UPON THE PEOPLE OF QUEENSLAND.**

Extension of power is based on the number of Covid-19 deaths in Queensland and the Covid numbers. This has been grossly exaggerated as noted in their statistics.

- **Covid-19 actually sits at number 38 of deaths in Australia** and this shows how little impact it really had on the population. It was 'blown out of all proportion' based on fear and incorrect reporting.
- **Only 2,639 deaths from Covid, out of 273,901 deaths within Australia over the last 22 months.**
- **92% of the Covid deaths have 3 serious underlying conditions.**
- **Covid related deaths – represent 1% of total deaths.**
- **Average age of death – 81 for men; 86 for women.** (both these are above our national average life span) This is in line with what was stated at the beginning of the pandemic, as to who would be the vulnerable groups. Those under this age and especially young people and children, had very little risk to no risk of dying from Covid-19.
- **More people have died from the flu than from Covid.** Eg. Over 22 months – 2.639 Covid deaths. In 2019, over a 12 month period – 4,124 deaths from the flu.
- **Only 83 people have actually died from Covid.**

COVID -19 MANDATES

THESE MANDATES HAVE DONE NOTHING TO HELP THE QUEENSLAND COMMUNITY, HAVE NOT DETERRED THE SPREAD OF COVID-19 NOR HAVE THEY CREATED A HEALTHY LIFESTYLE OR COMMUNITY FOR THE PEOPLE.

- **When vaccination mandates began in Queensland on 17th December: Fully vaccinated 83.6% with 2,227 cases.**
- **February 2022 - Fully vaccinated 90.6% with 523, 273 cases**
- **Since mandates began: Unvaccinated has fallen from 16.4% to 9.4 %, yet cases recorded have been around 530,000.**
- **Mandates have caused division in communities, families, organisations and workplaces.**
- **Restricting unvaccinated has created a 'leper', second-class group of people, who have been discriminated against.**
- **There is a 'pandemic' of vaccinated, not unvaccinated.** (Unvaccinated should not be held to blame or accountable for the spread of the virus, and therefore should not be shut out

from life and society and services)

- **Clear evidence that there is no difference in the spread of the virus between vaccinated and unvaccinated.**
- **Mandates are a waste of time – has made no difference to the spread.** The mandates have been a complete waste of time as it has become very clear that everyone can contract and spread the virus, no matter what their vaccination status.
- **Mandates have caused widespread shortages in many areas, such as healthcare, aged care, teaching, community care, fires and emergency services and more.**
- **Mandates have caused detrimental effects, physically, mentally, socially and financially on many people who have chosen to not be vaccinated.** These people need to have the chance to get their jobs back, find new ones if they can and have the ability to have a roof over their head and food on their table.
- **No need for a Vaccine certificate / passport – these need to be scrapped.**
- **Risk for adults dying from Covid – 0.5% / Risks for children and younger people – 0.002% (ABSOLUTELY NO NEED TO INOCULATE WITH AN EXPERIMENTAL ‘DANGEROUS’ ‘VACCINE’)**
- **Risk vs benefit ratio for the majority of the population is high vs negligible.** The ‘vaccines’ do not provide immunity or protection from Covid.
- **Evidence shows that the more inoculation received, the more the natural immune system is destroyed.** (UK Government data week 42, pages 23,24 state this and vaccinated have a harder time fighting off any variant and also any cold or flu or disease in the future)
- **Dr Luc Montagnier (Nobel laureate for discovering HIV virus), has warned that many vaccinated will test positive for HIV, thus causing a greater problem.**
- **Mandating EXPERIMENTAL ‘vaccines’ on a whole populace was against all science and not in the best interest of the people of Australia. Risk vs benefits should have been taken into account.**
- **All science shows that mass vaccinating into a pandemic causes variants and lessens the likelihood of ‘herd’ immunity.**
- **The small percentage of vulnerable and immunocompromised need to be looked after and be provided with appropriate treatment options. There have been successful treatments saving millions of lives around the world, from around March 2000.**
- **Science is ever evolving, especially as data comes out. Look at the science and realise that the way it has been approached in Australia has not worked.**
- **INFORMATION IS NOT MISINFORMATION – treatments which have been highly successful should not be banned (especially from someone like Mr Skerrick TGA, who has no medical background and not treated a patient in his life).**
- **PEOPLE’S RIGHTS TO REFUSE A MEDICAL PROCEDURE (experimental at that), SHOULD BE HONOURED. THEY NEED TO BE ALLOWED TO MOVE AGAIN WITH THE SAME RIGHTS AND OPPORTUNITIES AS THE REST OF SOCIETY.**
- **These ‘vaccines have been hailed as the most dangerous to be inflicted on mankind. If a safety board had been in place they would have been stopped in the first month due to the high amount of deaths and adverse reactions. The need for a booster within 12 months, proves they are ‘FAILED’ vaccines.**
- **There is a huge under-reporting and acknowledgement of the amount of deaths and adverse reactions from these ‘vaccines’. They should be stopped and there should be no more ‘ongoing’ roll-outs of vaccines and especially NO MANDATES**
