It has also been very clear from the start that Covid19 is an illness that specifically affects the vulnerable.

It remains the case, despite vaccination status, that the old and vulnerable are at most risk from this illness. The latest data from the Bureau of Statistics states the median age of covid deaths as 81 for men and 86 for women – both medians above the national average life span. In the time period covered by the Bureau, deaths due to Covid were 2,639 accounting with fewer than 1% of total deaths in Australia. Of these 2,639 deaths 92% had at least three serious underlying conditions.

It is essential to note that in the 12 months of 2019, 4,124 people died of the flu. Then over 22 months 2, 639 died from Covid. These facts suggest that this illness does NOT warrant the significant bureaucratic overreach and eradication of Human Rights wielded by the Government over the past two years.

The science and data regarding these vaccines are clear. Vaccinated people can still catch and transmit Covid19.

In Queensland, the vaccination mandate introduced on the 17th December, QLD had a vaccination rate of 83.6% and 2,227 cases. Two months later Covid Cases had jumped to 532,273 cases with a fully vaccinated population of 90.6%. Please note that during this period there were significant restrictions on Unvaccinated citizens.

In fact the new data emerging points to the detrimental effects of vaccine policy – specifically in regard to adverse effects – over reporting of covid death (with NOT of covid) and underreporting of vaccine injuries.

Three facts remain:

- The vaccines are approved for emergency use. They are on trial. Long term data is still emerging
- The vaccines do not stop transmission – in fact as per the Lancet study referenced above – in some cases transmission was more evident in certain contexts (households). It is very difficult to prove that there is any significant reduction in transmission when the viral load is at its peak.
- The vaccines do not significantly reduce severe illness/death – in fact the vulnerable that were at the most risk in the first instance are still at significant risk regardless of vaccination status.

I think our government needs to take a stand and be transparent about who actually is at risk from this new Flu called Covid. It is significantly less severe than the flu of 2019 and effecting the vulnerable.

20 months ago (March 2020) schools were called the safest place to be by the AHPPC. By the end of 2021 schools were classified as vulnerable settings. This change of rhetoric is not founded in data or science were school age students have virtually no risk of severe Covid or resulting death.

Vaccinate the vulnerable. Simple.

The government overreach has to stop. There is no justification to continue breaching Human Rights. This is no worse than the flu. Redact the mandates.
