RE: PUBLIC HEALTH AND OTHER LEGISLATION (EXTENSION OF EXPIRING PROVISIONS) AMENDMENT BILL 2022 (BILL)

I write for myself and on behalf of my family, where we formally advise that we do not support the Bill nor the extension of the state of emergency or the Public Health and other Legislation (Extension of Expiring Provisions) Amendment Bill of 2022. There is no justification for the extension. FOI requests have not been able to produce the documentation of the isolation of the SARS-COV-2 (virus), how can a pandemic be in existence without the virus being isolated? What verifiable evidence can be provided to the public that there is in fact a state of emergency?

The fear generated by the management of this pandemic has and continues to cause more harm to people's mental and physical health which are depleted now after over 2 years of over-management and their financial resilience degraded because of the misguided administration of the situation. The state and national economies have suffered under this form of management, destroying many small businesses, with many people forced out of their jobs and education of our children disrupted with the promotion of the mandates. The over policing of the population to control the public is unjustified and immoral.

Death rates from covid have been clearly overstated, our TGA and CDC acknowledging 8.6% and 6%, respectively, of COVID-19 deaths could be solely attributed to the virus. It has been stated that only 83 people have died of covid not with covid. The many statistics used to promote the fear of pandemic have been manipulated to present a narrative to support the fear being pushed on the Queensland and Australian population to maintain the state of emergency beyond what is

necessary. The media and government is responsible for perpetuating the fear rather than promoting the truth of the situation.
