I reject the Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022.

I do not agree to having the Acts listed in this Amendment Bill amended and extended yet again.

Queensland has been through enough difficulty throughout the past two years without a needless extension of provisions that were confusing, difficult to interpret, onerous to enforce, and negatively impacted citizens livelihoods, businesses, education, healthcare & mental health (to name a few areas).

The ramifications of these mandates have included - social discrimination, loss of jobs, a division between family and friends, confusion when "the goal posts keep changing".
