I, Shaun Macgillivray write to you to submit my rejection of the Public Health and Other Legislation (Extension of Expiring Provisions) Amendment Bill 2022.

Read carefully, what this CDC directive tacitly admits is that the PCR test cannot differentiate between "SARS-CoV-2 and influenza viruses". We have known this from the outset.

- The current Bureau of Statistics data clearly shows that over the 22 months of COVID 273,901 Australians died, however off these deaths only 2639 people were covered related with 92% of these having three serious underlying conditions. That means only 83 people have died directly of COVID. HOW CAN THIS BE DECLARED A PANDEMIC? Some 100,000 people died of cancer 32,000 died of heart disease 30,000 died of Alzheimer's and dementia and 10,000 died of diabetes. The rates of suicide have risen dramatically, and the social, financial, mental health and financial impacts have been catastrophic. I do not know who did the risk-harm analysis, but they need to be fired. COVID related deaths represent fewer than 1% of the total deaths in Australia over the past 22 months the median age of COVID related deaths was 81 for man an 86 for women. Both are above our national average life span. Where is the evidence that COVID 19 is as deadly as it is claimed to be because this evidence proves otherwise? Far more people died from the flu then COVID. We had 2639 COVID deaths over 22 months, however over a period of 12 months in 2019 4124 people died of the flu. That is a far worse death toll, and no draconian measures were necessary to get Australians through it.
- Lock downs are unlawful and there is no evidence that lockdowns have prevented the spread of COVID 19 and people's lives have been severely impacted by these. This isolation has negatively impacted on mental/physical health, family relationships, peoples working lives and have crippled people financially. Why has the government enforced this, knowing too well they are ineffective and detrimental?
