To Whom it may concern,

I understand that parliament is currently considering extending the Emergency Bill until 31 October 2022. For what reason! I think it's fair to say, we are now at a point where Covid did not end up being as bad that was originally predicted with most of the casualties being as a result of underlying issues and for most healthy people, they are unlikely to die from it. ### Flu vs Covid Deaths

I have attached a table of Flu vs covid deaths with most figures coming from the Australian Bureau of Statistics. You will note that there have been no deaths for the flu since 2020 (April). You will also note that two years of flu deaths compared to two years of Covid is a difference of 2850. Why is Covid considered a state of emergency when we are used to far worse with the flu seasons?


For two years we had no flu deaths in Qld. During most of that time there was only 7 Covid deaths. Yes, they have now increased since we opened the borders but not to the extent that was predicted. You will note that the average age of death in Australia has increased. This is amazing. Unfortunately, a part of life is death. Although no one wants to see a love one die, it is necessary and cannot be avoided. Covid is predominately killing people in Aged Care Facilities. It is assumed that many of these residents are in there because they are no longer able to care for themselves. These people are at the end of their lives and nothing we do is going to stop this, so we need to let them die with dignity and not isolated from the world. They deserve to be able to see their loved ones and enjoy what little time they have left.



This what was released as at the 16 February by the Queensland government. You will note that there have been 399 deaths in two years with 208 deaths being in aged care. What this doesn't say is there has been only 9 deaths in the under 40s with all of them having underlying issues.

#### TGA Data

This is the weekly report from the TGA of the adverse reactions to the vaccines.



To 20 February 2022, the total number of adverse event reports received with vaccine was not specified was 505.

Over 110000 adverse reactions from the vaccine. Some people are dying or ending up with serious health problems. Most people I know, now know of a person that has had a severe reaction and has been maimed or died although they keep being considered 'coincidental'. However, if you are cleared of covid and die within 28 days (now 14) you can be considered to have died a covid death. Hypocrisy!

### The Vaccines

What we know of the vaccine is, that it does not stop you from:

- Dying
- transmitting the virus;
- getting it.

And we have been told that it 'may' decrease our chances of dying, transmitting or getting it. Our children are not dying from the virus, so it needs to stop being pushed on them. They are far more likely to have an adverse reaction with the vaccine. If the vaccine is going to stop covid at over 90% vaccination rate, why are Emergency Powers needed if you trust that it is working?

### Personal information and experiences

I am a teacher aide that has been stood down due to me not wanting to be vaccinated. One of the reasons is because my Aunty died, possibly from the vaccine. Other reasons include, it is not fully approved and has not had adequate testing. I could not find enough information to validate its safety. I have lost my job, not because I am a danger to society or that I could infect another person - it is solely to punish me for not having an experimental drug that hasn't completed

safety trials adequately. This has caused me both emotional and financial stress. Not to mention the restrictions that have been placed on me. I have a story to tell, this week I ran into an old acquaintance. Her mother was in hospital due to an injury. She was in a bad way not expecting to make it and her family were finally allowed to visit. Suddenly she started to pick up. When asked what changed, she replied she thought no one loved her and that's why they were staying away. She had no reason to live. She is now on the mend and with family visits now allowed she continues to improve. I also have a close family friend who has been waiting for an operation on her heart for over two years and it is not booked in to be completed. She continues to suffer every day. These are the cost of the state of emergency. These are the statistics that are not being recorded.

### In conclusion

Countries all around the world are adjusting their covid death figures and returning to life as normal. Our government continues to push their mandates. There is no longer any need to do so. It's time to end the mandates, give businesses back control of their companies and to start to let us go back to normal – not the new normal. We have a new emergency to deal with and that is the floods. We need to mend relationships and get together to rebuild Queensland. We have suffered enough with the government bullying tactics and to extend the Emergency Bill until 31 October 2022, is a push for power, not in the people of Queensland's best interest!
