RE: Public Health And Other Legislation (Extension of Expiring Provisions Amendment Bill 2022 (Bill))

I wish to formally advise that I DO NOT support the Bill nor the extension of the state of emergency.

Queensland has been under a state of emergency (SOE) on 29 January, 2020.

The state of emergency no longer exists as far as COVID 19 is concerned because thankfully the Omicron variant is a mild form of COVID. Bill Gates the Microsoft Founder and funder of MRNA vaccines states in an interview at the 2022 Munich Security Conference:

“Sadly, the virus itself, particularly the variant called Omicron, is a type of vaccine.. That is it creates both B cell and T cell immunity. The original two strains of COVID 19 are gone and the vaccines were made for those so why coerce the general public with the threat of losing their livelihoods with ineffective and dangerous experimental MRNA vaccines?

During the initial rollout in late 2020, we were told that mass vaccination of 70% then 90% of the population, would be the only way to return to life as normal. We have reached targets so why persist with emergency powers?

MRNA vaccines have unusually high adverse side effects as seen from Australia Bureau of Statistics Data from the 5.3.6 Cumulative Analysis of Post Authorisation Adverse Events Reports (BNT162B2) received through 28 February 2021: Page 7 lists Adverse side effects to 29914 Females and 9182 Males. (Table 1).

The current vaccines on offer do not prevent transmission of the virus despite the lies told by public health officials and politicians in 2020. The countries that suffered the first waves of COVID 19 have alarming statistics such as in Scotland on page 38 of the Public Health Scotland showed the double vaccinated were twice as likely to become infected with COVID and the triple vaccinated were also at an increased risk of infection. In Denmark a study of vaccine effectiveness against SARS-COV-2 infection showed negative efficacy for both the Pfizer and Moderna vaccines of -76% and -39% respectively at 90 to 150 days post vaccination. (<https://www.medrxiv.org>)

Why on Earth does Queensland persist with undemocratic governance under the guise of public health when 9 countries around the world: 1. United Kingdom. 2. Ireland 3. Denmark. 4. Sweden. 5. Norway. 6. Tanzania. 7. Nicaragua. 8.. Dominican Republic and 9. Iceland have dropped COVID restrictions? Other countries are beginning to ease their internal restrictions such as Mexico, El Salvador, South Africa and Portugal has removed testing for vaccinated tourists. Is the purpose of the Public Health And Other Legislation proposed Bill is to “extend amendments to the Corrective Services Act 2006” for the purposes of imprisoning vaccine free citizens in quarantine facilities? All of the Acts including the Disaster Management Act 2006 and the Mental Health Act of 2016 are bills that were written in a world that did not have the COVID 19 Pandemic. Should not those Bills be revised and not tinkered with to take away fundamental human rights?

This SOE has contributed to the rise in demand for mental health service since March 2020 (<https://documents.parliament.qi.gov.au/committees/HEC/2020/tms-22Jan2021-PH.pdf> and the fear generated through inaccurate modelling of COVID death such as this example from the Imperial College in London which forecast a drastically inaccurate death toll of almost 10 fold above the later reported deaths of COVID 19 disease from March to October 2020 with predicted deaths at 510 000 reported deaths 46 603 (<https://worldometers.info/coronavirus/country/uk>).

An extension of emergency powers would exacerbate the mental health issues for ordinary citizens with the aftermath of lockdowns and terminating people’s livelihoods for a dodgy vaccine.

Why doesn’t the Queensland government support innovative and successful vaccines from Australian Professor [REDACTED] COVAX 19 Spikogen vaccine is used in Iran! He lost his position at a South Australian University because he took his own vaccine and not the mandated experiment ones. His own research raises alarm bells about the spike protein compounds in MRNA Multinational Pharmaceutical vaccines and he quotes research that boosters actually increase inflammation in the human body.
