**RE: PUBLIC HEALTH AND OTHER LEGISLATION (EXTENSION OF EXPIRING PROVISIONS)
AMENDMENT BILL 2022 (BILL)**

On behalf of my family, I am writing to formally advise that we do not support the Bill nor the extension of the state of emergency in association with the so called Covid19 pandemic.

The powers sought and wielded over the past 2+ years, used by Government under the guise of an emergency is disproportionate to the risk posed by Covid 19.

Queensland was the first state to declare a state of emergency (SOE) on 29 January 2020. This means that if the SOE laws are extended from 30 April 2022 to 31 October 2022, Queenslanders will have been under a SOE for nearly three years.

The Premier speaks proudly of the governments achievements in keeping Queenslanders safe, however this itself is questionable on many fronts. To list but a few:

- The validity of the PCR test
- The suppression of alternative treatments both in prevention and acute applications
- The absence of education in effective actions to promote health and support natural immunity
- The failure to recognise natural immunity
- The rise in mental health issues and demand for mental health services
- The degradation of the family unit
- Damage to the education and wellbeing of children that will not be fully realised for years to come
- Silencing of health professionals
- Destruction of our health care system
- Distrust of the government, the law enforcement and judicial system.
- Censorship of information

As the scientific and medical evidence reportedly used as the basis for the formulation of the health advice and subsequent directives under the State of Emergency has not been made available, one can only assume that sufficient medical and scientific evidence to rightly justify the government actions around Covid19 does not exist.

To the contrary, The Grand Jury hearing in the Court of Public Opinion, as organised by [REDACTED] [REDACTED] has heard the evidence of global experts in all fields associated with the Covid19 pandemic. The evidence of each of these expert witnesses can be heard here and in short, gives justification for

the immediate cessation of the state of emergency and in fact, immediate withdrawal of the rollout of the injections and related Covid19 measures.

Should the nature of the presentation of this evidence be dismissed, it is relevant to note that every expert witness will independently conclude that the measures adopted by governments under the Covid19 state of emergency is disproportionate to risk. Open debate should be welcomed in a public forum before further intrusion is placed upon the freedoms and basic human rights of the population.

Considering this evidence, it must be concluded that the state of emergency at this point is less about managing a crisis, and more about retaining the powers and control gained over Queenslanders since the start of the pandemic. It is not sufficient for any person to claim ignorance to the damaging effects of the acts of our governments in relation to this so-called pandemic.

If I, as a lay person, have access to such credentialled information and can determine that the continuance of the state of emergency at this point would be fraudulent in nature, there is no excuse for persons employed in positions to act in the best and honest interests of the citizens of this country to continue in supposed ignorance of this information. Such continuance would only be seeking to damage the health, wellbeing and economic position of the population of Queensland and serve an alternate agenda that is not in the best interests of the population.
