**RE: PUBLIC HEALTH AND OTHER LEGISLATION (EXTENSION OF EXPIRING PROVISIONS) AMENDMENT BILL 2022**

Dear Committee Secretary

Please see below points outlining my **formal objection** to "Public Health and other legislation (extension of expiring provisions) amendment bill 2022".

Excerpt below from the above mention bill explanatory notes

"As at 16 February 2022, the World Health Organization reported a total of 414,525,183 confirmed positive COVID 19 cases reported globally. The Australian Government Department of Health reported 2,609,599 confirmed COVID 19 cases, including 4,732 deaths in Australia. In Queensland, there have been 507,746 confirmed cases of COVID 19, with 399 deaths relating to COVID 19 being Queensland residents."

- How can the Queensland Parliament warrant the extension of the expiring provisions under the guise of a "State of Emergency" when **COVID 19 has a mortality rate in Australia of 0.0018%** using the data quoted in the explanatory notes for the bill?
- How can the Queensland Parliament warrant the extension of the expiring provisions under the guise of a "State of Emergency" when **COVID 19 has a mortality rate in Queensland of 0.00078%** using the data quoted in the explanatory notes for the bill?
- Further to the points stated above, as of the 7<sup>th</sup> of February 2022, the requirement to check in was removed. From the 4<sup>th</sup> of March, the requirement to wear masks will be removed and density requirements and social distancing will no longer apply
- These points suggest that the risk from COVID 19, is a low to negligible level, for both contraction of and from
- The continued discrimination against the unvaccinated (who have made a choice not to risk the COVID 19 experimental drug that is still in a trial phase and has no long-term data regarding adverse effects and is now causing deaths and injuries here and around the world from side effects listed and unlisted by the manufacture) is unwarranted when one considers that this drug does not stop the transmission or symptoms of Covid. Indeed, according to the figures there seems to be a larger proportion of hospital admissions and deaths in people who have been injected with this experimental drug as opposed to those who have not. The infection rate increased substantially despite the increase of 90+ % in vaccination rates; this would suggest that this drug is not doing what it is supposed to do.
- I am supposedly in the high-risk category, yet my personal experience of having Covid without these drugs was one of Flu symptoms. I isolated, with a few days bed rest and supplements and got through it without "clogging up the hospital system" (as I was told by this government I would) or passing it on to someone else. I put this down to common sense and taking responsibility for my health nutritionally and with exercise. I think the health department would be better to aim their time and our Taxpayer dollars at promoting this side of health.
- My grandchildren and great grandchildren have their whole lives ahead of them, putting them at risk from this experimental drug to supposedly protect me or their elders when they have a very high chance of surviving Covid naturally is not acceptable.

- When will the Queensland state parliament acknowledge **the will of the people** and drop all COVID 19 related mandates that are causing segregation, mental health issues and stigmatisation of the people of Queensland? To say nothing of high unemployment and economic devastation of small businesses.
- 2 million Australian people converged on Australian Parliament house on Saturday the 12<sup>th</sup> February 2022. This is unprecedented in all of Australian history. When is enough, enough, the people of Queensland and Australia have had enough of this tyrannical and draconian dictatorship which we have all been living under for the past two (2) years and you the politicians are required to follow the will of the people.
