I was also at one point unable to travel to My apiary site to inspect my Bee colonies due to local travel restrictions put in place by the current Queensland government , hive inspections are a vital duty of a beekeeper to be able to identify and manage pests and devastating diseases , failure to do so is an agricultural biosecurity risk/offence . this is a negative aspect of travel restrictions that I believe was hugely overlooked not just for apiculture but for many other agricultural industries as well .

I have also been affected socially , being unable to attend certain venues has dwindled my social life and now my day to day life mostly consists of work and Home duties without any reprieve from the mundane .

I have been made out to be a second-class citizen in my own country and have been discriminated against by many businesses who fear the consequences of the unjust mandates imposed upon them and the penalties if they do not comply , businesses who rely on a fully open and free market to survive have been starved of a vast portion of income and I have witnessed many such businesses fail under these Vaccination mandates.

I'm now a second-rate citizen in the eyes of many due to the divisive propaganda campaigns proliferated through the community by the government and media. These mandates have destroyed the lives of many, undermined the faith and trust that Queenslanders and Australians have in their government and elected officials. We have been lied to by bureaucrats who wish to abuse the powers granted to them by emergency powers and the time to put an end to this madness is now. Queenslanders no longer wish to partake in the division, fear and deceit embraced by the Queensland Labour government. There is no further justification for these powers.
