I am writing to register my objection to the Extension to the Emergency Bill, currently being tabled in Queensland Parliament. It is my view, based upon numbers and actual data, that there is no current public emergency and therefore no need to extend this bill until 31st October 2022. This state public health emergency has been going on now for more than 2 years. How incompetent do you need to be to need to continue extending this Public Health Emergency? It seems that this act is on the verge of being extended because, as Yvette D'Ath says " the virus is unpredictable". Well, I've got news for her- life is somewhat unpredictable. And yet, we haven't felt the need to live in a permanent state of emergency before this time.

There are more deaths due to cancer or heart disease each year than due to Covid-19, and this has been the case from the very beginning of the so-called 'pandemic'. There are many covid-19 cases in Queensland, as shown from the numbers, but these are now generally mild as the symptoms of an Omicron infection are much less intense than the original strain (ie. not requiring hospitalisation) and with the increase in therapeutics such as monoclonal antibodies, treatment for even severe cases is available and effective and patients rarely requires ventilation. Although Covid-19 is still present in the community, there is absolutely no justification for extending the Public Health Emergency again, on a possibility that things may get worse. It is appearing as if the Queensland Government is enjoying the extra powers it has, and has no desire to give up those powers even when it is clearly unnecessary, as now. If the Government does not know how to step back and give the people their own autonomy and responsibility back, we will do our best at election time to make sure these power hungry denizens do not remain in power for any longer than necessary.

These emergency powers have done nothing but harm the people, destroy economies and livelihoods, encourage separation and isolation, all whilst having no effect upon case numbers. Our Government should be aiming to represent and unite all the peoples of the state of Queensland. This Government has stopped doing this. The emergency bills have caused segregation and the demonisation of people who remain vaccine-free due to their rational concerns over these injections that are causing thousands of adverse effects (evidenced in the DAEN system and also provided as warnings on the product itself) and not preventing covid-19 infections. Studies from Israel, for example, have shown there is a huge surge in cases mainly from the highly vaccinated population. Therefore the segregation mandates only serve the purpose of isolating and discriminating against a portion of society. This must stop.

These measures relating to Covid-19 have caused extreme anguish to those members of society who have been outcast. They have been made to feel gaslighted, like they are not as worthy as the rest of the population. The measures undertaken by the government have been highly discriminating and pure coercion and bribery. According

to the Nuremberg Code, no person is to be subject to coercion or discrimination in order to take an experimental drug. These drugs have not finished clinical trials (and never will due to the unblinding of participants and removal of controls) and are clearly experimental.

Regarding the medical and hospital system, the directives in this act have removed thousands of nurses and doctors from their chosen profession. If you really want to make sure the system can cope with numbers of patients, people should not be forced from their jobs by their medical choice. The other result of these directives is that it emboldens some practitioners to deny care, treatments and assessments to the vaccine-free. We should all be able to access medical care, and even though the directives do not strictly deny emergency care, they are themselves creating emergencies where there should be none, if preventative care was carried out.

Small businesses are being discriminated against, with the contradictory requirements for small cafes, etc compared to food courts in malls, for instance. As the emergency act calls for discrimination against individuals, they are completely unlawful and should never have been passed. The emergency measures should never have been allowed to override basic human rights and privacy acts. Using them in this way is a blatant disregard for an individual's freedom. Many businesses cannot find staff who fit the criteria of being 'up to date' on their injections and others have had to close as they do not want to be forced to discriminate against their fellow man.

Please, take a look at the data, both here at home and internationally. And stop extending the Public Health Emergency. It is your duty as our elected officials.
